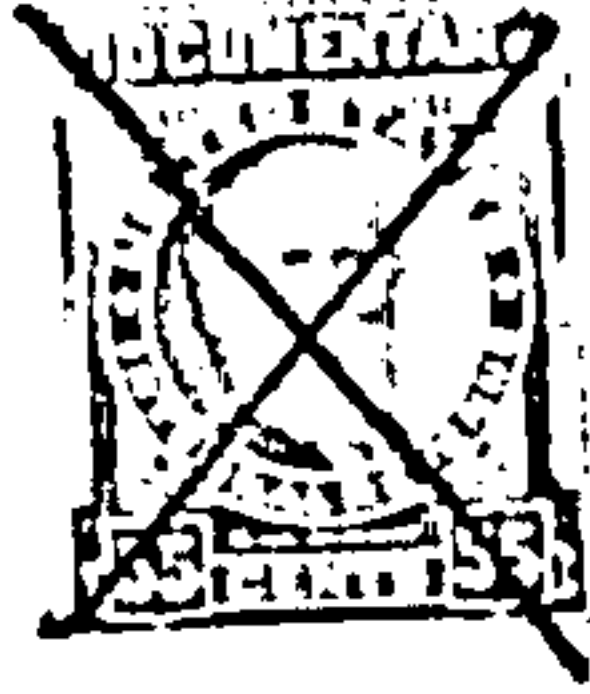
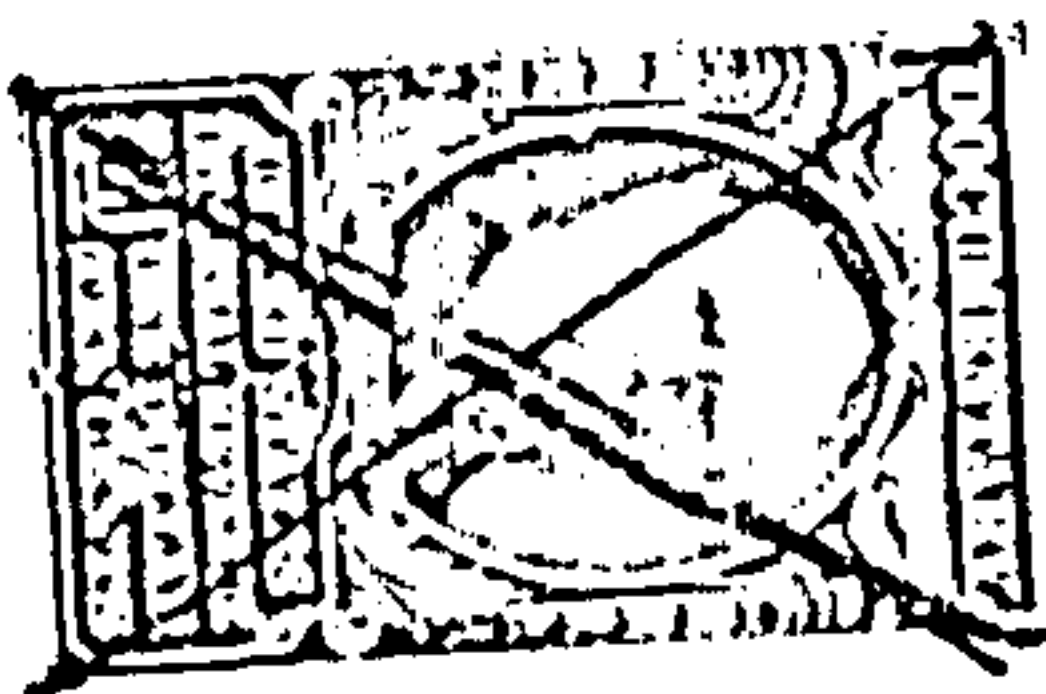
to the undersigned grantor, **Siluria Mills, Inc.** a corporation,
