Grover White and Goldie H. White

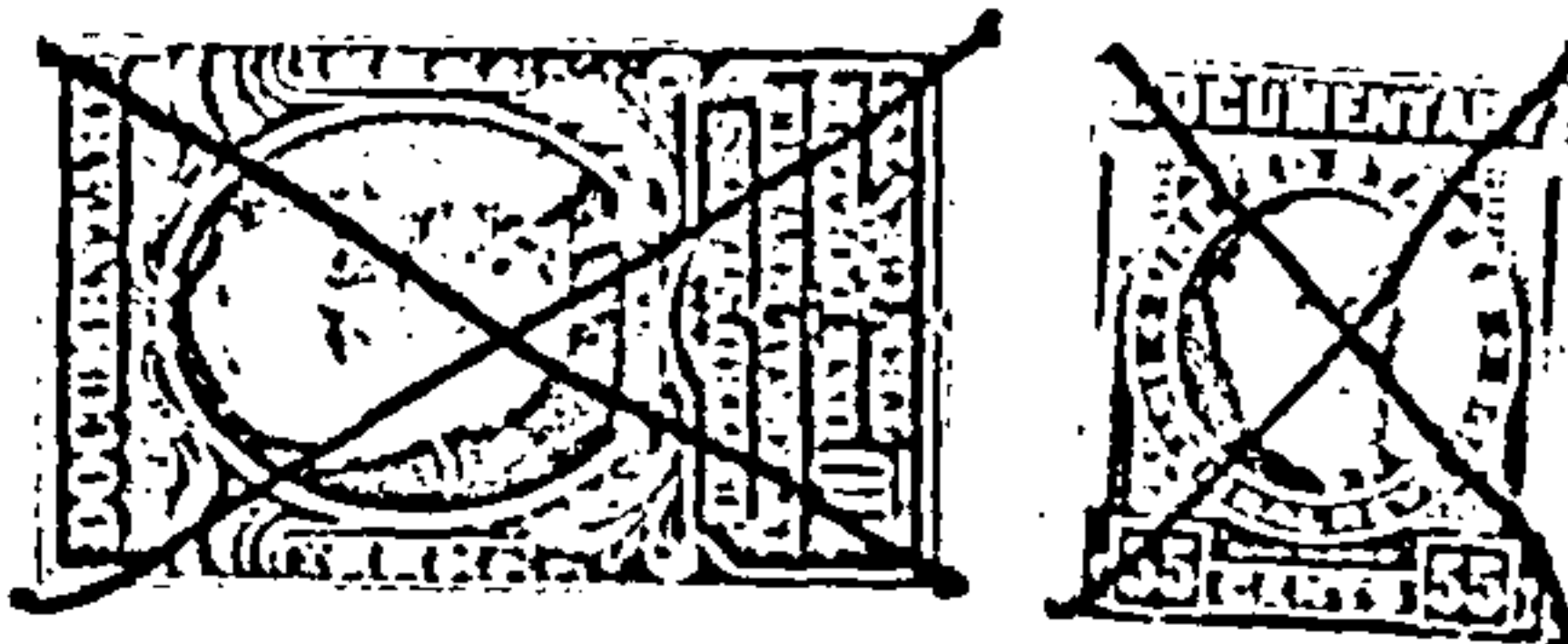
