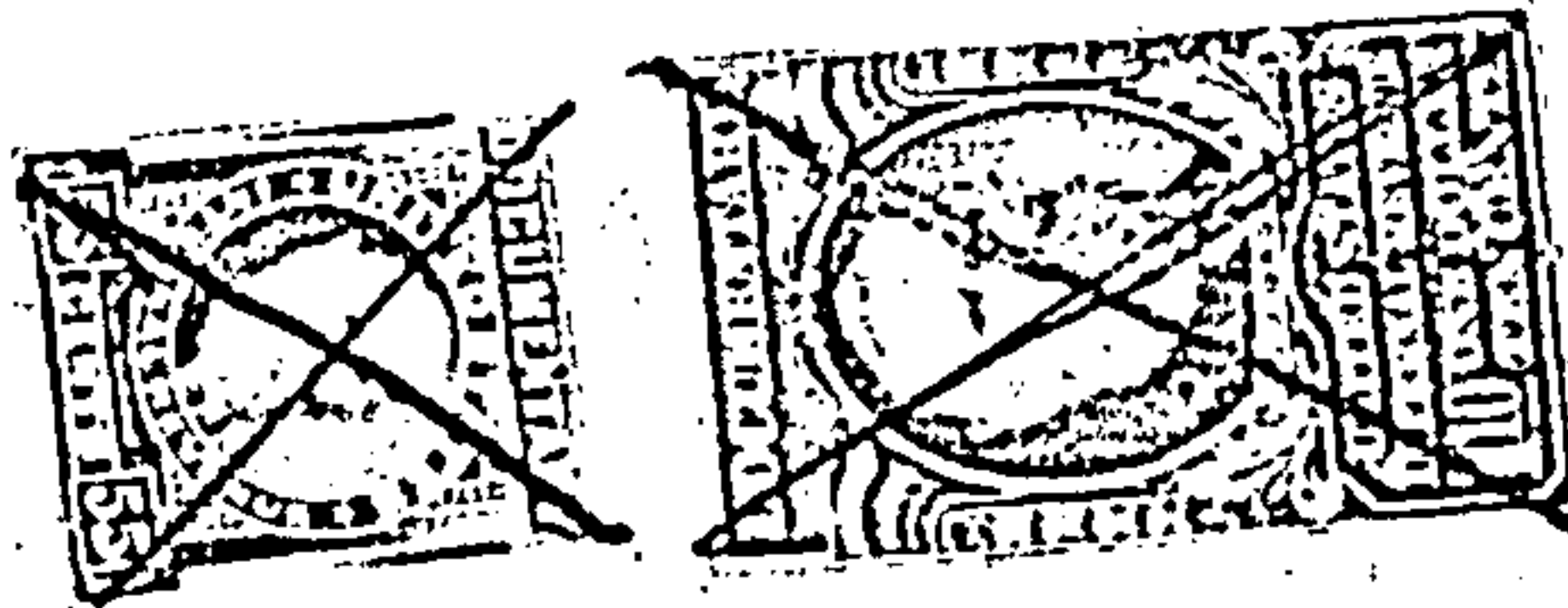
to the undersigned grantor, **Siluria Mills, Inc.** a corporation,

Lot No. 35 as shown on a map entitled "Property Line Map, Siluria Mills" prepared by Joseph A. Miller, Reg. Civil Engineer on October 5, 1965, and being more particularly described as follows:
