Daniel Clegg

and to his heirs and assigns forever.

of the GENERAL LAND OFFICE to be hereunto affixed.

in the year of our Lord one thousand eight hundred and sixteen and of the  
INDEPENDENCE OF THE UNITED STATES the eighty fifth.
