KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned,  
C. A. Kunz and wife of the County and State  
aforesaid, in and for the consideration of One Dollar (\$1.00) in hand  
paid by Shelby County, the receipt whereof is hereby acknowledged and for  
the further consideration of the benefit accruing to us and to the public  
from the construction or improvement of a public road through our lands in  
Shelby County, and the proper drainage thereof, do hereby give, grant,  
bargain, sell and convey unto Shelby County, its successors or assigns,  
an easement of \_\_\_\_\_ feet in length and \_\_\_\_\_ feet in width for the  
purpose of constructing an inlet and/or outlet ditch to properly accommodate  
drainage for Highway project No. 4507-A. Said easement herein conveyed  
shall begin at a point 40 feet north of, and at right angles to, the  
center line of said project at station 26+35; ~~thence north along the~~  
~~center line of said project a distance of~~ thence north 133' in length and 30' in width along the east property  
line; thence northwest along the center of said easement a distance of  
175' in length and 60' in width. Said land is located in SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ,  
Sec. 34, T 21 S, R 2 E.

to the point of ending.

The parcel of land in which said easement is located and lying is the  
SE $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 33, Township 21 S, Range 2 E.  
situated in Shelby County, Alabama.

TO HAVE AND TO HOLD unto said Shelby County, its successors or assigns,  
and for and in consideration of the benefit to our property by reason of the  
construction or improvement of said road and drainage, we hereby release the  
Shelby County aforesaid, and all of its employees and officers, and the State  
of Alabama and all of its employees and officers from all consequential  
damages, present or prospective, to our property, arising out of the construc-  
tion, improvement, maintenance, or repair of said easement, ditch, or drainage  
ditch. The grantors hereby grant permission with right of ingress and egress  
to grantors adjoining property at any time for the purpose of constructing or  
maintaining the said ditch or easement.
