the further consideration of the benefit accruing to us and to the public
from the construction or improvement of a public road through our lands in
Shelby County, and the proper drainage thereof, do hereby give, grant,
bargain, sell and convey unto Shelby County, its successors or assigns,
an easement of see below feet in length and 80 feet in width for the
purpose of constructing an inlet and/or outlet ditch to properly accommodate
drainage for highway project No. SACP 4491-A said easement herein conveyed
shall begin at a point feet of, and at right angles to, the
center line of said project at station ; thence along the
center line of said herein conveyed easement a distance of

tion, improvement, maintenance, or repair of said easement, ditch, or drainage
ditch. The grantors hereby grant permission with right of ingress and egress
to grantors adjoining property at any time for the purpose of constructing or
maintaining the said ditch or easement.
