I, A. A. Johnson, a resident citizen of Starrett, Shelby County, Alabama, being of sound mind and disposing memory, and more than twenty-one years of age, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any and all former wills heretofore by me made.

ITEM I

I direct that all of my just debts, including the expenses of my last illness and funeral, be paid by my Executrix, hereinafter named, as soon after my death as she shall deem advisable.

ITEM II

I give, devise and bequeath unto my children; namely, Millie Spradley, James Johnson, Clint Johnson and Robert Dalton Johnson, all the rest, residue and remainder of my property, of any and every nature and character whatsoever, and wheresoever situated, all to be theirs absolutely, to share and share, equally.

ITEM III

*A. A. Johnson*

I hereby nominate, constitute and appoint my daughter, Millie Spradley, as the Executrix of this my Last Will and Testament and I hereby specifically exempt her from giving any bond or bonds whatsoever in connection with her appointment as Executrix of my estate and in connection with the administration of my estate by ~~her~~<sup>her</sup>. And I do hereby further specifically exempt my said Executrix from filing any inventory and from making any report whatsoever in or to any court or person of her acts and doings as the Executrix of my estate. And I do hereby vest in my said Executrix full power and authority to sell and convey all or any part of my property, real, personal or mixed, upon such terms and conditions as she may approve, at public or private sale without securing authority therefor from any court or person whatsoever.
