This acknowledges receipt of your letters of May 9, 1966, regarding certain parcels of tax property.

No. 1. Tax sale in name Owner Unknown to the State of Alabama dated June 28, 1892, covering SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 31, Township 21, Range 1 East, and other property.

We are unable to locate this tax sale on our records.

No. 2. Tax Sale in name J. T. Johnson to State of Alabama made in July 3, 1922 for 1921 taxes covering SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 31, Township 21, Range 1 East.

We are unable to locate this tax sale on our records.

No. 3. Tax Sale in name T. J. Womack and Olivia to State of Alabama dated July 2, 1923, for 1922 taxes covering SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 31, Township 21, Range 1 East.

There is a notation on our records stating that this tax sale was erroneous and that taxes were paid by Mr. J. T. Johnson.

No. 4. Tax Sale in name T. J. and Oliver Womack to State of Alabama dated July 12, 1924, for 1923 taxes covering SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 31, Township 21, Range 1 East.

There is a notation on our records stating that this property was sold by the State in 1923.

No. 5. Tax Sale in name Sam Blount dated September 25, 1933, for 1932 taxes covering SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 31, Township 21, Range 1 East.

Our records indicate that this property was redeemed by R. T. Kirkland on July 6, 1940. This redemption was reported on Judge of Probate redemption report for July of 1940.



No. 6. Tax Sale in the name Mrs. Pauline Armstrong to State of Alabama dated July 3, 1922 for 1921 taxes covering 15 acres in SE $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 4, Township 19, Range 2 East, Shelby County, Alabama.

There is a notation on our records indicating that taxes were paid on this property on December 11, 1921, and tax collector's receipt No. 5072 was issued.
