Before me, L. E. Parker, a Notary Public in and for the State of Alabama at Large, personally appeared, Minnie Benson, who, after first being duly sworn, deposes and says as follows.

My name is Minnie Benson. I am 76 years of age and reside in Shelby County, Alabama in the vicinity of the land described hereinbelow. I have been familiar with this land and have known its possessors for more than 60 years. This land is best described as:

All that part of the Southeast Quarter of Northeast Quarter (SE¹ of NE¹) of Section 12, Township 24 North, Range 15 East, that lies Southwest of Spring Creek, except that part subdivided and known as Glasscocks Subdivision, Spring Creek, according to map as recorded in Map Book 4 on page 23 in Probate Office of Shelby County, Alabama. Also excepting rights and interest of Alabama Power Company to all above described lands that lie below 425 foot contour line established in Survey of Coosa River made 2nd August 1903 by the Corps of Engineers.

Also Lots 1, 2, 3, 4, in Block 1 and Lots 1, 2, 3, 4, 6, 7, 8, 9 and 10 in Block 2; and Lots 1, 2, 3, 4, 5, 6, 7, 8, and 9 in Block 10, all according to Glasscocks Subdivision, Spring Creek as recorded in Map Book 4 on page 23 in Probate Office of Shelby County, Alabama.

Excepting rights and interest of Alabama Power Company to all above described lands that lie below the 425 foot contour line established in Survey of Coosa River made 2nd August 1903 by the Corps of Engineers.

I know that K. N. Matthews (also known as Reverend Matthews and Keener Matthews) was in possession of the above described land under the claim of title from prior to 1905 until in about 1946, when he conveyed title to this land and relinquished his possession of A. V. Glasscock. The said A. V. Glasscock has subdivided portions of this land and has sold parcels of this land to other persons as lots, but has continued as possessor of the remaining lands under the claim of title up until the present time.

I know that A. V. Glasscock, the above named lot owners and their predecessors in title have been in the actual, continuous, and exclusive possession of all the hereinabove described land for more than 60 years. Their possession has been visible, open, hostile and notorious. They have assessed this land for taxes and have paid the taxes due thereon.

I know that A. V. Glasscock, the herein named lot owners and their predecessors in title have constructed dwelling houses, cabins, storage house and other necessary outbuildings on this land. They have dug well, installed gas, water and sewage systems on this land. They have built boat docks, launching ramps and boat houses. A. V. Glasscock has operated a fishing camp on his portion of this land for about 20 years. He has operated a store, rented boats, leased lots, sold bait and other acts necessary to his fishing camp. Some of the herein named land owners have used their respective lands as security for mortgages, have leased and even sold portions of their lands and have exercised every other act necessary to the peaceful use and enjoyment of their respective land.

I know of no person or persons claiming any right to this land or disputing the possession of this land by A. V. Glasscock, the herein named person claiming title through the said A. V. Glasscock and their predecessors in title, under the claim of ownership, during the past 60 years.

I know that Eunice O. Matthews and Eunice P. Matthews are one and the same person.
