EASEMENT

KNOW ALL MEN BY THESE PRESENTS, That Town of Wilsonville, Alabama,
a municipal corporation, for and in consideration of One Dollar
(\$1.00) to it in hand
paid by Southern Electric Generating Company, a corporation, the receipt of
which is acknowledged, does hereby grant, bargain, sell and convey unto
Southern Electric Generating Company, a corporation, its successors and
assigns, the right to construct, operate and maintain an underground drainage
line and related facilities connected therewith, and do all things necessary
with respect thereto from time to time upon, under, through and across a
parcel of land as hereinafter described, together with all the rights and
privileges necessary or convenient to the full use and enjoyment thereof for
the purposes above described, including the right of ingress and egress to and
from such parcel, and which such parcel of land is located in Shelby County,
Alabama, and described as follows:

Such parcel is more particularly described as being
located along the southern edge of the Kennedy Avenue
right-of-way from its intersection with the eastern
boundary of the Mitchell Street right-of-way to its
intersection with the Wilsonville drainage ditch, a
distance of approximately 570 feet, all located in
Wilsonville, Alabama in the W $\frac{1}{2}$ of SW $\frac{1}{4}$, Section 6,
Township 21 South, Range 2 East, and which shall be of
sufficient width to permit the said Southern Electric
Generating Company, its successors and assigns, to install
an underground drainage line of at least 36 inches and
more; together with the right to empty the run-off water
from the Ernest C. Gaston Steam Plant ash settling basin
via such drainage line into the Wilsonville drainage
ditch and to construct a concrete catch basin at the
point where the drainage line empties into the drainage ditch.

TO HAVE AND TO HOLD the same unto the said Southern Electric Generating
Company, its successors and assigns forever.
