My name is Homer J. Walton and I am o3 years of age. I presently reside at Columbiana, Shelby County, Alabama. I have been familiar with the occupation, us and possession of the hereinafter described real property for a period in excess of 50 years, to-wit:

Beginning at the SE corner of Section 22, Township 21 South, Range 1 West; thence run North 2 deg. 00 min. West along the East boundary of said Section a distance of 1,223.30 feet to a point; thence turn an angle of 91 deg. 02 min. to the left and run South 80 deg. 52 min. West a distance of 638.09 feet to a point; thence turn an angle of 88 deg. 38 min. to the left and run South 1 deg. 40 min. East a distance of 1,248.41 feet to a point; thence turn an angle of 93 deg. 34 min. 30 sec. to the left and run North 84 deg. 39 min. 30 sec. East a distance of 640.45 feet to the point of beginning. Said parcel of land lying in the SE4 of SE4, Section 22, Township 21 South, Range 1 West, Shelby County, Alabama, and containing 18.21 acres.

When I first became familiar with the occupation, use, and possession of the above described property it was claimed by Shelby County, Alabama, and was essentially timber land. In the early 1930's the above described property was cleared for the purpose of establishing an airport. The above described property was a part of the Columbiana Airport as erected and established by the Works Project Administration in the early 1930's. Since the early 1930's the above described property has remained cleared and been used for a landing strip and airport for private aircraft. Actually, the use of the above described property for an airport has been available continuously and exclusively since that time but due to varying conditions of the surface the same has seen only limited use through the years. However, during the more than 50 years I have known the occupation, use, and possession of the above described property it has beenclaimed by Shelby County, Alabama, and no other person, firm, or corporation has claimed said land or asserted any right, title, or interest therein, and no other person, firm, or corporation other than said Shelby County has been in possession of the same or any part thereof. During the more than 50 years I have known the occupation, use, and possession of the above described property the land has beentreated by the community as owned by Shelby County and knowledge throughout the community that said Shelby County owned said property was wideopread. Neither A. W. Gay, his descendants, heirs, or his predecessors in title have asserted any right, claim,


