That in consideration of and other good and valuable considerations

to the undersigned grantor Frank B. Yeilding, Jr. (also known as F. B. Yeilding, Jr.) and Malcolm C. Jeter (also known as M. C. Jeter) in hand paid by Frank B. Yeilding, Jr. and wife, Augusta S. Yeilding

the receipt whereof is acknowledged we the said Frank B. Yeilding, Jr. and wife, Augusta S. Yeilding, and Malcolm C. Jeter and wife, Mary Wilson Jeter

grant, bargain, sell and convey unto the said Frank B. Yeilding, Jr. and wife, Augusta S. Yeilding a one-half (1/2) undivided interest in and to as joint tenants, with right of survivorship/the following described real estate, situated in

Shelby County, Alabama, to-wit:

A part of the NWA of SWA, Section 23, Township 19, Range 1 East, described as follows: Commencing at the Northeast corner of said forty and run South 86° 30' West 334.0 feet to point of beginning of tract herein described; thence run South 13° 30' East a distance of 770.0 feet; thence run South 74° West 306.0 feet to a point; thence run South 24° East 468.7 feet to the North right of way line of Florida Short Route Highway; thence in a Southwesterly direction along said highway right of way to the South line of said forty; thence West along South line of said forty to Southwest corner; thence North along the West line of said forty to the Northwest corner; thence East along the North line of said forty to point of beginning; subject to easement of Plantation Pipe Line Company;

Also a part of the Swa of Swa, Section 23, Township 19, Range 1 East, described as follows: Commencing at the Northwest corner of said forty and run East along said forty line 630 feet to point of beginning of the land herein described; thence run South to the North right of way line of Florida Short Route Highway; thence run in a Northeasterly direction along said highway right of way to North line of said forty; thence run West along the North line of said forty to point of beginning.

TO HAVE AND TO HOLD Unto the said Frank B. Yeilding, Jr. and wife, Augusta S. Yeilding

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, except any liens of record and unpaid ad valorem taxes,

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
