KNOWN ALL MEN BY THESE PRESENTS, that The Board of Trustees of the University of Alabama, a corporation, acting by and through its duly authorized Executive Committee, composed of John A. Caddell, as Chairman, and Thomas S. Lawson and Ernest G. Williams, as members thereof, for and in consideration of the sum of TWENTY-FIVE AND NO/100 (\$25.00) DOLLARS and other good and valuable consideration to it in hand paid by Victor Scott, the receipt whereof is hereby acknowledged, does remise, release, quit claim and convey to the said Victor Scott, his heirs, his successors or assigns, all its right, title and interest in and to the following described real property, to-wit:

## PARCEL 1:

A lot in the Town of Montevallo, Alabama, described as follows: Commencing at the southernmost corner of intersection of Broad and Shelby Streets in said Town of Montevallo and running in a southwesterly direction along Broad Street a distance of 60 feet to point of beginning of lot herein described; thence in a southeasterly direction and perpendicular to Broad Street a distance of 100 feet; thence in a southwesterly direction and parallel to Broad Street a distance of 90 feet to the SW line of Lot 43 according to Original Plan of Town of Montevallo; thence run in a northwesterly direction along southwest line . of said Lot 43 and also parallel to Shelby Street a distance of 100 feet to southeast margin of Broad Street; thence in a northeasterly direction along southeast margin of Broad Street a distance of 90 feet to point of beginning, and being a part of Lots 42 and 43 according to Original Plan of the Town of Montevallo, Alabama.

## PARCEL 2:

The southeast one-half (SE½) of Lot 17 and the northeast 22 feet of the southeast one-half (SE½) of Lot 16, all according to the original plan and survey of the Town of Montevallo, the property hereby described front 97 feet on the northwest line of Main Street and runs back in a northwesterly direction of uniform width along the southwest line of Shelby Street 150 feet.

## PARCEL 3:

run thence northwest along the line of the Webb lot 133 feet; run thence southwest and parallel with Valley Street to the West line of SW% of SW% of Section 21, Township 22, Range 3 West; run thence south along said west line of said forty to the northwest line of Valley Street; run thence northeast along the northwest line of Valley Street to the point of beginning; except lot sold to William Conwell which is described as: Commencing at a point where the southwest margin of Shelby Street intersects the northwest margin of Valley Street and go thence in a southwesterly direction along the north-. west margin of Valley Street 425 feet to point of beginning of lot excepted; thence continue along the northwest margin of Valley Street 50 feet; thence in a northwesterly direction and perpendicular to Valley Street 133 feet; thence in a northeasterly direction and parallel to Valley Street 50 feet; thence in a southeasterly direction and perpendicular to Valley Street 133 feet to point of beginning of said exception. PARCEL 4:

A part of Lot 9 according to "Allotment of Lands at Montevallo, made by Electa S. Storrs and Lizzie B. Troy, as shown by map known as Storrs' and Troy map of the Town of Montevallo, recorded in Map Book 3 page 3 in the Probate Office of Shelby County, Alabama, and being more particularly described as follows: Begin at the northeast corner of Lot 8 as shown on Storrs and Troy map surveyed and drawn by N. B. Dare, and proceed south 39 deg. 25 min. east 30.68 feet to a 3/4" pipe marker for point of beginning of the tract herein described; thence south 40 deg. 00 min. east and along the northeast side of an alley 81.0 feet; thence north 48 deg. 30 min. East 111.0 feet; thence north 44 deg. 25 min. west 89.5 feet; thence south 43 deg. 53 min. West 104.65 feet to the point of beginning.

PARCEL 5:

Beginning at the northwest corner of Lot No. 5, the same being the northeast corner of F. F. Crowe lot, then run in a northeasterly direction along the southeast margin of Main Street for 188 feet to the point of beginning, being the northernmost corner of lot formerly owned by Smitherman (now owned by Victor Scott); thence in a southeasterly direction and perpendicular to Main Street 158 feet and 1½ inches; thence in a northeasterly direction and parallel with Main Street 81 feet, more or less, to an alley; thence in a northwesterly direction and perpendicular to Main Street 158 feet 13 inches to the southeast margin of Main Street; thence in a southwesterly direction along the southeast margin of Main Street 81 feet to point of beginning, being a part of lot 5½ and lot 8 according to Storrs and Troy Addition to Montevallo, as further shown by tracing of the map entitled Storrs & Troy by N.
