follows:

That he is 45 years of age and presently resides at HEZENA,
ALA.; that he has been acquainted with the occupation, use
and possession of the following described property for the last past 20 years:

The SW $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 4, Township 22 South, Range 1 West.

The SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 4, Township 22 South, Range 1 West, EXCEPT
the following described parcel: Commence at the SW corner of said
 $\frac{1}{4}$ $\frac{1}{4}$ Section and run North along West line a distance of 450 feet to

R. H. Comer or any other person, firm or corporation has been in possession
of the above described property or any part thereof, other than affiant and
his wife, and their predecessors in title.

G. T. Kirkpatrick and wife, Elsie own said land in fee simple, and since the
time that he first knew the land it has been owned by the present owners, and
their predecessors in title and has been occupied by them actually, exclusively,
