of ONE AND NO/100 ——— Dollar (\$ 1⁰⁰), to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power, with the right to string thereon from time to time, electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, under, over, and across the following described land situated in SHELBY County, Alabama:

Commence at NW corner of Sec 2 of T4N of R6E of Sect 25 Township 20 Range 3 West, thence run southerly along west boundary of said Sec 2 of R6E 272 ft to point of beginning thence run 90° left and easterly 138 ft, thence run southerly and parallel with west boundary of said Sec 2 of R6E to the south boundary of said Sec 2 of R6E, thence run westerly along south boundary 138 ft, to southwest corner of said Sec 2 of R6E, thence run northerly along west boundary of said Sec 2 of R6E to point of beginning.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines, and also the right to cut and keep clear all trees and to keep clear other obstructions that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
