County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter
described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be 40
road, as it is now located and staked out by the Highway Department or as much of our lands as is required to
make afoot right-of-way acress our lands, said right-of-way herein conveyed being more
particulary described as follows, to-wit: And as shown on the right-of-way map of Project NoCP2-87 as recorded in the office of the Judge of Probate of Shelby County.

Begin at a point on the centerline of Project CP2-87 at Station 50+50 where centerline of said project intersects the west property line; thence in an easterly direction along centerline of said project along a 3 curve to the right a distance 200' to the point of ending at Station 52+50, where centerline of said project intersects the east property line.
