

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

STATE OF ALABAMA

Shelby County

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

_____ and wife _____ of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

see below _____ feet in width on _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. CP2-87 as recorded in the office of the Judge of Probate of Shelby County.

Begin at a point 40' right of and at right angles to Station 47+00 of Project CP2-87, where the 40' right of way line of said project intersects the north property line; said point being a point in the center of the present dirt road; thence northeasterly along the center of said dirt road a distance 150' to a point on the centerline of said project at Station 48+30, thence northeasterly along centerline of said project along a 2°30' curve to the right a distance 165.7' to the point of ending of the curvature of the centerline; thence N 83°54' E along centerline of said project a distance 2.9' to the point of beginning of the curvature of the centerline; thence southeasterly along centerline of said project along a 3° curve to the right a distance 451.4' to the point on the east property line at Station 54+70; thence South along the east property line a distance of 42' to a point on the south 40' right of way line of said project; thence northwesterly along 40' right of way line of said project along a 3° curve to the left a distance of 442.1' to the point of ending of the curvature of the 40' right of way line; thence S 83°54' W along 40' right of way line of said project a distance 2.9' to the point of beginning of the curvature of the 40' right of way line; thence southwesterly along the 40' right of way line of said project along a 2°30' curve to the left a distance 310.3' to the point of beginning.

Said parcel of land is lying in the NW¼ of NW¼, Sec. 22, T 21 S, R 3 W and contains .62 acre, more or less, including that part now occupied by the present road.

All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
