

RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

Howard Lee

and wife

Lucile Lee

of the

County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be

feet in width on

side of the center line of said

road, as it is now located and staked out by the Highway Department or as much of our lands as is required to

make a _____ foot right-of-way across our lands, said right-of-way herein conveyed being more

particularly described as follows, to-wit: And as shown on the right-of-way map of Project No CP2-87 as recorded in the office of the Judge of Probate of Shelby County.

Begin at a point on the centerline of Project CP2-87 at Station 109+76, where centerline of said project intersects the west property line; thence N 89° 00' E along centerline of said project a distance of 255' to the point of ending at Station 112+31, where centerline of said project intersects the west 40' right of way line of State Highway 119.

Said parcel of land being 30' wide on the left (north) side of centerline of said project also to include a flare beginning at a point 40' left of and at right angles to Station 111+27 of said project; thence N. 89° 00' E along the 30' right of way line of said project a distance 90', more or less, to a point on the west 40' right of way line of State Highway 119; thence northwesterly along said State Highway 119 right of way a distance 90' to a point; thence southwesterly a distance 100' to the point of beginning.

Said land is lying in the SW $\frac{1}{4}$ of SW $\frac{1}{4}$, and SE $\frac{1}{4}$ of SW $\frac{1}{4}$, Sec. 14, T 21 S, R 3 W and contains .26 acres, more or less, including that part now occupied by the present road.

The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
