Before me, the undersigned authority in and for said State and County, personally appeared H. T. Holcombe and wife, Myrtle Holcombe, who being by me first duly sworn, depose and state on oath as follows:

On September 9, 1950, your affiants gave a quitclaim deed to Stephen Buchina and wife, Mary Rosalia Buchina, on the hereinafter described real estate:

A part of the E $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 20, Township 19, Range 1 East, particularly described as follows: Commence where the East line of said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said Section 20 crosses the North line of the Florida Short Route Highway (Highway 91) - (Now 280); run thence west along the North line of said Highway a distance of 210 feet to the SW corner of the property of H. T.
