Before me, L. E. Parker, a Notary Public in and for the State of Alabama at Large, personally appeared T. A. Weldon , who is known to me and after first being duly sworn, deposes and says as follows.

My name is T. A. Weldon . I am 69 years of age and reside in Shelby County, Alabama. I have been familiar with the land described hereinbelow and have known its possessors for more than 30 years. This land is best described as:

Southeast Quarter of Northwest Quarter (\$\frac{1}{2}\) of Section 1, Township 2h North, Range 15 East, Excepting rights and interest of Alabama Power Company to all above described lands that lie below the 425 foot contour line established in Survey of Coosa River made 2nd August 1903 by the Corps of Engineers.

I know that the above described land was generally known throughout this vicinity as the T. R. Lovett farm and in about 1925, the heirs of Thomas R. Lovett were in exclusive possession of this land under the claim of ownership. In about 1931 the said heirs conveyed this land and other lands by deed and relinquished their possession to A. C. Goodwin who soon thereafter conveyed the above described land to Mrs. Fannie P. Hoover who was in possession of this land as title claimant until in about 1934 when she conveyed this land to Eva Taylor who moved into immediate possession of this land under the claim of ownership and has so continued up until the present time.

The said Eva Taylor was married to L. P. Lovett several years ago, and they have maintained a home and raised a family on this land. The said L. P. Lovett is known to me and others in this community as Leroy Lovett.

I know that Eva Taylor Lovett and her predecessors in title have been in the actual, continuous and exclusive possession of the hereinabove described land for more than 30 years. Their possession has been visible, open, hostile and notorious. They have assessed this land for taxes and have paid the taxes due thereon.

I know that Eva Taylor Lovett and her predecessors in title during the past 30 years have constructed and occupied a dwelling house on this land. They have constructed a barn and other necessary outbuildings and have fenced and cross-fenced portions of this land and have kept livestock thereon. They have dug wells, planted gardens, trees and major crops of cotton and corn and have granted right-of-ways over this land and have exercised everyother act necessary to the peaceful use and enjoyment of this land as was consistent with the nature of the land.

I know of no person or persons claiming any right to this land or disputing the possession of this land by Eva Taylor Lovett and her predecessors in title during the past 30 years.

I know that Alabama Power Company acquired some of the T. R. Lovett farm for the lake created by the construction of Lay Dam and this was the land that was leased to W. P. Eason for use as farm land. I know that W. P. Eason never claimed title to the hereinabove described land and was in possession of adjacent lands only as lessee.
