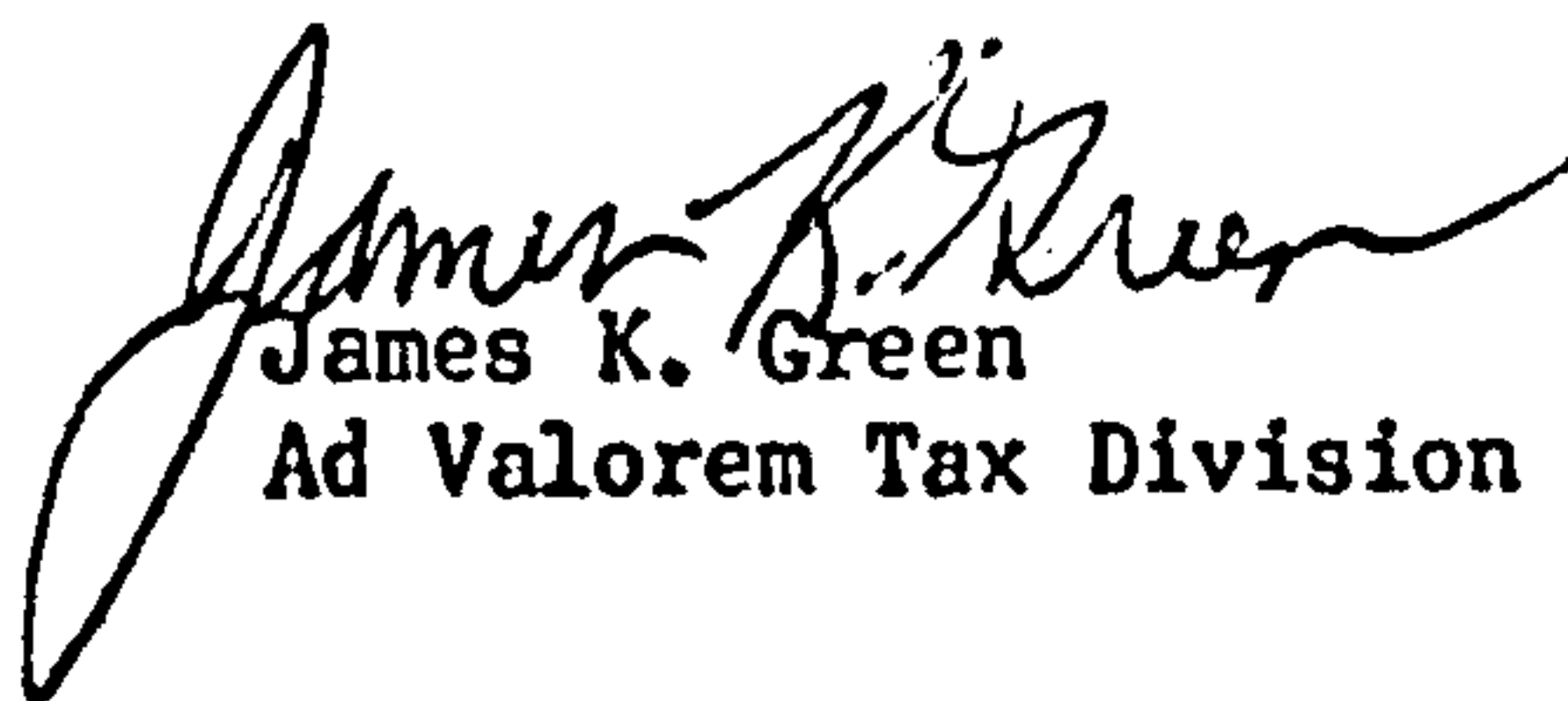
This acknowledges receipt of your letter of December 2, 1966, regarding a parcel of property sold for taxes in Shelby County.

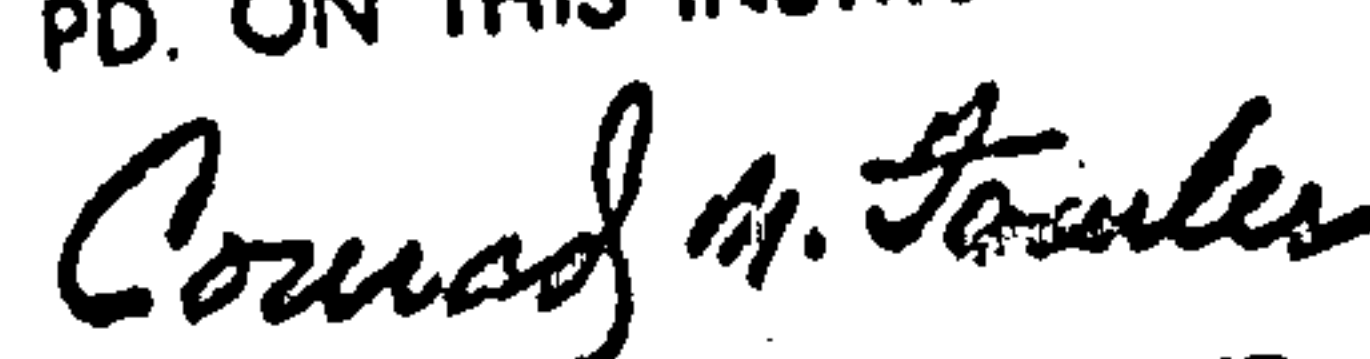
