MORTGAGE RELEASE

KNOW ALL MEN BY THESE PRESENTS, that whereas, Joe M. Arledge and wife, Betty M. Arledge executed a mortgage to Victor Scott on the 13th day of June, 1966, which is recorded in Mortgage Book 201 page 433 in the Probate Office of Shelby County, Alabama;

WHEREAS, said Joe M. Arledge and wife, Betty M. Arledge desire to pay the sum of Four Thousand and no/100 Dollars to said Victor Scott on said mortgage and to have the land described below released from said mortgage and said Victor Scott desires to accept said Four Thousand and no/100 Dollars as consideration for the releasing of said property and agrees to release said land from said mortgage;

Now, therefore, the undersigned Victor Scott in consideration of Four Thousand and no/100 Dollars being paid to him in hand paid by the said Joe M. Arledge and Betty M. Arledge, the receipt whereof is hereby acknowledged, does hereby release, remise and quit claim unto the said Joe M. Arledge and Betty M. Arledge, all my right, title and interest acquired under said mortgage in and to that part of the premises conveyed therein, and described as follows, to-wit:

All being situated in Shelby County, Alabama.

TO HAVE AND TO HOLD to the said Joe M. Arledge and Betty M. Arledge, and to their heirs and assigns forever.

It is understood and agreed that this release shall not in any way impair or affect the right of the said mortgagee to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid on said mortgage.


