I, the undersigned, WILLIAM SHELTON PRITCHARD, a resident of the City of Birmingham, State and County aforesaid, being of sound mind and disposing memory, do hereby make, publish and declare this to be my last will and testament, hereby expressly revoking any and all wills heretofore made by me.

## Item One

It is my express will and desire that all of my just debts, including the debts of my last illness, funeral, burial expense, and all taxes, be paid by my Executors hereinafter named out of the assets of my estate as soon after my death as the condition of my estate will permit.

### Item Two

I hereby will, devise and bequeath to Childrens Hospital,
Birmingham, Alabama, Two Hundred Fifty and no/100 (\$250.00) Dollars;
Holy Family Hospital for negroes, Ensley, Alabama, Two Hundred Fifty
and No/100 (\$250.00) Dollars; St. Francis Xavier Roman Catholic Church,

St. Paul's Roman Catholic Church, Birmingham, Alabama, Two Hundred

#### Item Three

I hereby will, devise and bequeath unto my beloved and devoted wife, Catharine Robinson Pritchard, in the event she survives me, one-half (%) of the rest, residue and remainder of my estate and property, including both real estate and personal property, to be here absolutely as of the day and hour of my death. It is my express will and desire, and I hereby direct that she under this item of my will shall take not less than the full marital deduction as provided by the Federal Estate Tax Statutes, and as defined in the applicable Treasury Department Regulations effective as of the day and hour of my death.

### Item Four

From the remaining one-half (%) of the rest, residue and remainder of my said estate and property. I hereby make the following bequests.

to such of the named beneficiaries as survive me; in the event any beneficiary named in this item of my will predeceases me, then in such event the bequest as to such deceased person shall fail.

McCall, Five Hundred and No/100 (\$500.00) Dollars; unto Alexander W. Jones, Five Hundred and No/100 (\$500.00) Dollars; unto John H. Harper, Five Hundred and No/100 (\$500.00) Dollars; unto my long time and valued associate and secretary, Margaret (Peggy) Beuerlein, for a lifetime devoted to my profession, Five Thousand and No/100 (\$5,000.00) Dollars; unto Camellia Ann Petty, Two Hundred Fifty and No/100 (\$250.00) Dollars; unto Mary Louise Dean, Two Hundred Fifty and No/100 (\$250.00) Dollars. All of said bequests to be paid in cash.

- (b) I hereby will, devise and bequeath unto my devoted and beloved sister, Lenna Pritchard Christensen, Five Thousand and No/100 (\$5,000.00) Dollars; to my devoted sister-in-law, Margaret (Peggy) Delaney Pritchard, Two Thousand Five Hundred and No/100 (\$2,500.00) Dollars; to my devoted sister-in-law, Mary Robinson Craig, Two Thousand Five Hundred and No/100 (\$2,500.00) Dollars; to the children of my beloved and devoted sister, Geraldine Pritchard Norton, namely: Joseph Norton, Jr., One Thousand and No/100 (\$1,000.00) Dollars; Geraldine Norton Morris, Two Thousand and No/100 (\$2,000.00) Dollars; to each of the children of my beloved and devoted brother, Vivian Ross Pritchard, namely: William Pritchard, Five Hundred and No/100 (\$500.00) Dollars; Margaret Ruth Pritchard Tenhundfeld, One Thousand and No/100 (\$1,000.00) Dollars; James Ross Pritchard, Five Hundred and No/100 (\$500.00) Dollars. Each of said bequests herein made to be paid in cash by my Executors hereinafter named, as soon after my death as the condition of my estate will permit.
- (c) I hereby will, devise and bequeath unto my son, William S. Pritchard, Jr., all of my office furniture, fixtures, library, going practice of law, and any interest in money due but not collected by the partnership law firm of which I am a member. The cash due from the said partnership of which I am a member shall be included as part of my general estate, and devised as herein provided.
- (d) I hereby will, devise and bequath unto my said son, William S. Pritchard, Jr., subject to a life estate in my devoted and beloved wife, his mother, Catharine Robinson Pritchard, the lands which I own in Shelby County, Alabama, near Saginaw, upon which there is presently situated a lake and a cabin. This bequest includes the land that I own in Shelby County, Alabama, known as the lake property, and all furniture and fixtures located in said cabin, or used in connection therewith, intact as the same exists as of the day and hour of my death; but does not include any other lands separate and apart from said lake property that I might own in Shelby County, Alabama. (e) I hereby will, devise and bequeath unto each James Ross Forman, Sr., Robert Bruce Lindsay, Sr., and Donald Ross Pritchard, Sr., Five Thousand and No/100 (\$5,000.00) Dollars, that is, Five Thousand and No/100 (\$5,000.00) Dollars in cash to each.

### Item Five

All the rest, residue and remainder of my estate and property, after the payment of debts and the bequests hereinabove made, I hereby will, devise and bequeath unto such of my devoted and beloved children as survive me, namely, Mary Pritchard Forman, Catharine Pritchard Lindsay, William Shelton Pritchard, Jr., and Donald Ross Pritchard, in equal parts, share and share alike. In the event any child of mine herein named predecease me, leaving issue of his or her body, then, in such event, that part of my said estate herein bequeathed to such child, I hereby will, devise and bequeath to the child or children of said deceased child living at the time of my death, in equal parts, share and share alike. Said children taking per stirpes the part of their parent.

#### Item Six

In the event my said devoted and beloved wife, Catharine Robinson Pritchard, should predecease me, or we should both die in a common disaster, then in either of said events, I hereby will, devise and bequeath all that part of my estate herein bequeathed to her, to our said four devoted and beloved children, named in the preceding Item Five of this my will, in equal parts, share and share alike, the children of any deceased child to take their parent's part as therein provided.

Executors, as may qualify hereunder, full power and authority to sell and dispose of any, and if needs be, all property, including both real estate and personal property, of which I die, seized and possessed, for such price and upon such terms and conditions, as they in their sole wisdom and discretion may deem to be for the best interest of my estate, without the order or approval of any Court whatsoever.

I further hereby expressly exempt my said Executors, or such of them as may qualify hereunder, from the necessity of filing any inventory or final settlement of my estate in any Court whatsoever.
