Before me, L. E. Parker, a Notary Public in and for the State of Alabama at Large, personally appeared Margaret B. Robertson, who is known to me and after first being duly sworn, deposes and says as follows.

My name is Margaret B. Robertson. I am 55 years of age and reside in Shelby County, Alabama in the vicinity of the land described hereinbelow. I have been familiar with this land and have known its possessors during the past 30 years. This land is best described as:

Southeast Quarter (SE $\frac{1}{4}$), Section 19, Township 20 South, Range 2 East;
East Half of Northeast Quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$), Section 30, Township 20
South, Range 2 East;
Shelby County, Alabama.

I know that in about 1936, the above described land was in the possession of Roberta W. Taylor who claimed title thereto. In about 1958, the said Roberta W. Taylor conveyed this land by deed and relinquished her possession to Roberta T. Thayer and Louisa Cleghorn who have continued in this position up until the present time.

I know that Roberta T. Thayer, Louisa Cleghorn and their predecessors in title have been in the actual, continuous and exclusive possession of the hereinabove described land for more than 30 years. Their possession has been visible, open, hostile and notorious. They have assessed this land for taxes and have paid the taxes due thereon.

I know that Roberta T. Thayer, Louisa Cleghorn and their predecessors in title have used the hereinabove described land in connection with adjacent lands for timber farming. Several years ago portions of this land was used for growing major crops of cotton and corn. They have granted easements, hunting permits and have exercised every other act necessary to the peaceful use and enjoyment of this land as was consistent with the nature of the land.

I know of no person or persons claiming any right to the hereinabove described land or disputing the possession of this land by Roberta T. Thayer, Louisa Cleghorn and their predecessors in title during the past 30 years.

I more particularly know that A. M. Word, Ernest W. Snow or their heirs have not been in the possession of the hereinabove land during the past 30 years nor have they exercised any right, act or authority over this land during this time.

I know that the hereinabove described land was not the homestead of Kate H. Wallace or any heirs of W. W. Wallace or their spouses in October 1915, or at any other time prior or since said date back as far as I can remember.

I know that Louisa Cleghorn is one and the same person as Louisa T. Cleghorn.
