Affiant is informed that Albert I. Cox purchased the land for its taxes in 1946 and affigat knows that Albert L. Cox and wife sold the land to J. A. Hines on July 16, 1946, as shown by deed book 127 page 290 in said Probate Office. The said J. A. Hines went into immediate possession of the land and claimed to own it and paid taxes thereon until 1950 when he sold it to Floyd I. Hawkins and wife. 
