The SE corner lot fronting 75 feet on the Montevallo-Ashville Road, and running back to a depth of 150 feet in the pl^t of ground known as the Acker Field. Further description and boundaries as follows: Beginning at a point on the NW line of the Montevallo and Ashville Road, or extension of Main Street in the Town of Montevallo, which is SW from the North and South half mile line of Section 21, Township 22, Range 3 West.
