WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR—LAWYERS TITLE INSURANCE CORPORATION, Birmingham, Alabama

SHELBY COUNTY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Four Thousand Two Hundred Fifty and no/100----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, S. B. McClure, Executor of the Last Will and Testament of Juanita Thornton Williams, dec'd (herein referred to as grantors) do grant, bargain, sell and convey unto Wilburn Q. King and Annie Mae King

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Commence at the southwest corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 1, Township 21 South, Range 1 East, thence run east along the south line of said $\frac{1}{4}$ - $\frac{1}{4}$ Section a distance of 80.00 feet; thence turn an angle of 90 deg. 00 min. to the left and run a distance of 45.62 feet to the south R.O.W. line of Ala. Highway No. 25; thence turn an angle of 81 deg. 52 min to the right and run a distance of 259.39 feet to a point on said R.O.W. line; thence turn an angle of 2 deg. 30 min. to the right and run a distance of 51.20 feet to a point on said R.O.W. line; thence turn an angle of 00 deg. 31 min. to the left and run a distance of 135.49 feet to a point on said R.O.W. line and the point of beginning; thence continue in the same direction along said R.O.W. line a distance of 10.00 feet; thence turn an angle of 2 deg. 16 min. to the left and run a distance of 90.25 feet to a point on said R.O.W. line; thence turn an angle of 99 deg. 1 min. to the right and run a distance of 274.64 feet to the north R.O.W. line of the Southern Railroad; thence turn an angle of 65 deg. 16 min. to the right and run a distance of 112.75 feet to a point on said R.O.W. line; thence turn an angle of 115 deg. 19 min. to the right and run a distance of 306.14 feet to the point of beginning; situated in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 1, Township 21 South, Range 1 East.



TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
