

DEED OF DEDICATION TO THE TOWN OF HELENA, ALABAMA

KNOW ALL MEN BY THESE PRESENTS, that F. F. Mullins and wife, Ethel Mullins; James F. Shackelford and wife, Lillian J. Shackelford, do hereby dedicate to the Town of Helena, Alabama, the right of way hereinafter described, for use as a public street, to wit:

A 50-foot right of way, the center line of which is described as follows: From the southeast corner of the N 1/2 of SE 1/4, Section 15, Township 20 South, Range 3 West, run west along the south line of said N 1/2 of SE 1/4 for a distance of 328.22 feet to a point; thence turn an angle 70 degrees 30 minutes to the right and run a distance of 505.37 feet to the point of beginning of the right of way herein conveyed; thence turn an angle of 83 degrees 16 minutes to the left and run southwesterly along the center line of said strip of land herein conveyed a distance of 526.53 feet to a point; thence continuing along said center line along a 2 degree 30 minute curve to the right a distance of 450 feet to a point; thence continue along said center line in a westerly direction a distance of 50.28 feet to the point of ending.

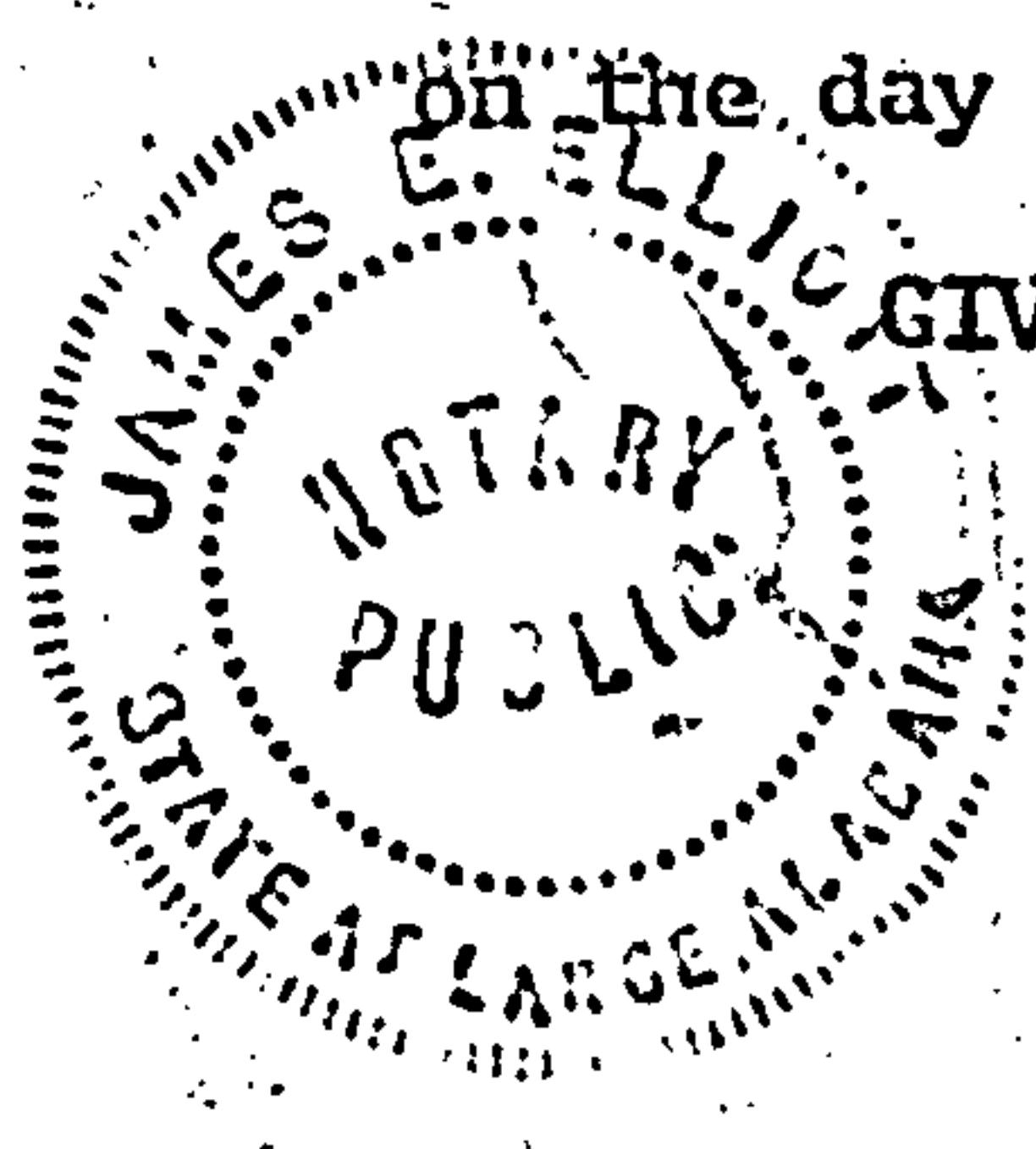

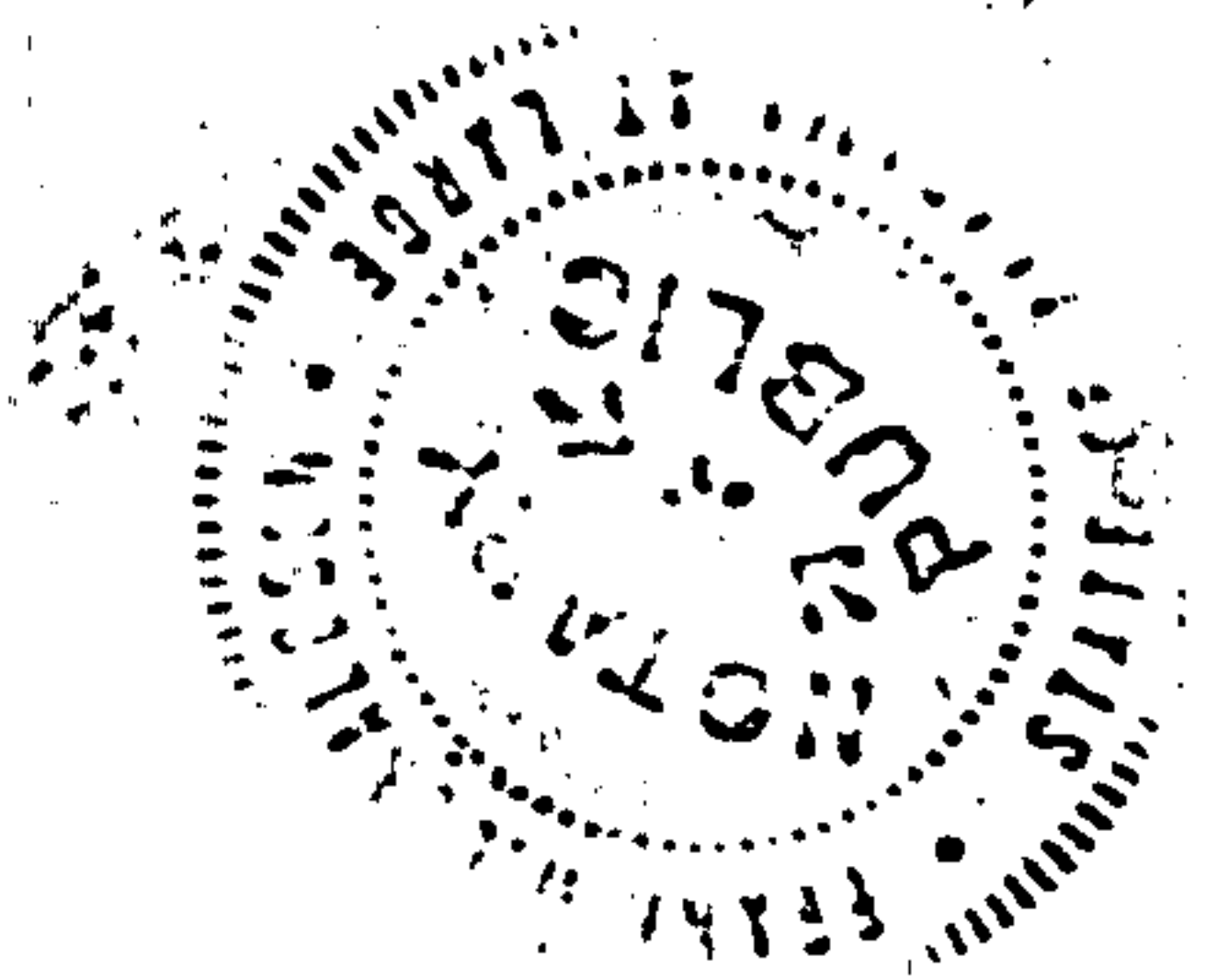
