Commence at the Southeast corner of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 23, Township 21 South, Range 1 West; thence North 28 deg. 16' East a distance of 273.65 feet to the point of beginning of the parcel of land herein described; thence turn an angle of 65 deg. 57' to the left and run South 85 deg. 47' West a distance of 79.98 feet to a point; thence turn an angle of 84 deg. 53' to the right and run North 9 deg. 20' West a distance of 252.64 feet to a point; thence turn an angle of 95 deg. 30' to the right and run North 86 deg. 10' East a distance of 80.0 feet to a point; thence turn an angle of 84 deg. 30' to the right and run South 9 deg. 20' East a distance of 252.15 feet to the point of beginning. Said parcel of land is lying in the City of Columbiana, and is located in the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 23, Township 21 South, Range 1 West, and contains 0.46 acres, more or less.
