## PARTIAL MORTGAGE RELEASE

Commence at the NE corner of the NET of the NNT of Section 9, Township 20 South, Range 2 East; thence run West along the North line of said Section a distance of 339.16 feet; thence turn an angle of 63 degrees 50 minutes to the left and run a distance of 827.01 feet; thence turn an angle of 118 degrees 00 minutes to the left and run a distance of 210.00 feet; thence turn an angle of 100 degrees 30 minutes to the right and run a distance of 400.00 feet to the point of beginning; thence turn an angle of 3 degrees 26 minutes to the right and run a distance of 190.00 feet; thence turn an angle of 76 degrees 04 minutes to the right and run a distance of 488.73 feet to the East right-of-way line of Alabama Highway No. 25; thence turn an angle of 103 degrees 56 minutes to the right and run along said right-of-way line a distance of 190.00 feet; thence turn an angle of 76 degrees 04 minutes to the right and run a distance of 488.73 feet to the point of beginning. Situated in the NET of the NAT of Section 9, Township 20 South, Range 2 East, Shelby County, Alabama.

the following described tract is also made a part of this conveyance: A plot or parcel of land immediately adjoining the East side of the lot described above, the same being more particularly described as follows: Begin at the beginning point of the tract described above; thence East, and along the line of the North boundary of the above described tract, for a distance of 114 feet to a point; thence southwesterly and parallel to the East boundary of the above described tract for a distance of 190 feet to a point; thence West and parallel to the North boundary of the above described tract for a distance of 114 feet to the Southeast corner of the above described tract; thence northeasterly along the east boundary of the tract described above, for a distance of 190 feet, to the point of beginning.
