W. B. WILLIAMS and wife, MARYNAN B. WILLIAMS

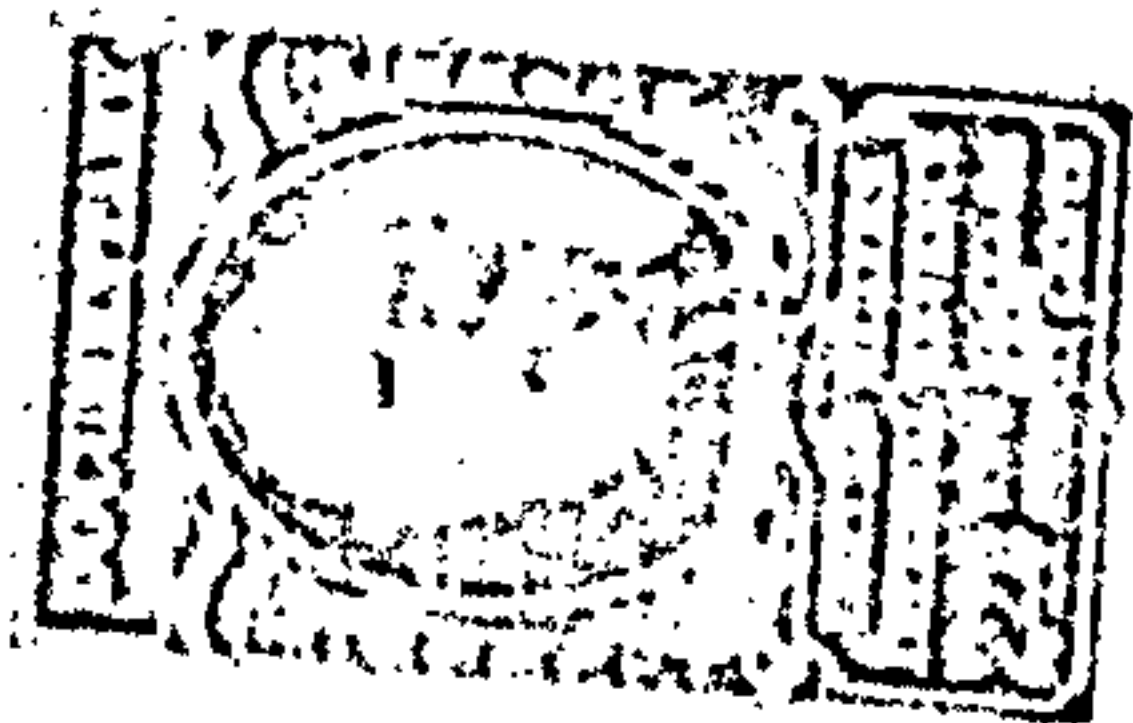
