LAST WILL AND TESTAMENT

KNOW ALL MEN BY THESE PRESENT, that I, Floyd Rufus Turner, of Shelby County, Alabama, being of sound and disposing mind and memory, do hereby make, publish and declare this to be my last will and testament, hereby revoking any will or codicil previously made by me, at any time.

I

I hereby direct that all of my just debts, including my funeral expenses and the expenses in connection with the administration of my estate, be paid as soon as possible after my death.

II

I hereby give, bequeath and devise unto my son, Floyd Rufus Turner, Jr., my Winchester, pump-action, shot-gum, to be his absolutely.

III

I hereby give, bequeath and devise unto my beloved wife, Eunice Aster Turner, all of my household furniture and fixtures, together with all of my personal assets contained therein, to be hers absolutely.

IV

I hereby grant unto my beloved wife, Eunice Aster Turner, for the remainder of her natural life, a life estate in all of my real property, of whatsoever nature and wheresoever situated, which I might own or possess at the time of my death.

I hereby give, bequeath and devise unto my children, namely, Eugene Turner Brasher, Evelyn Turner Grantham, Charles Turner, Jackie Turner Brasher, Branda Turner Thompson and Floya Rufus Turner, Jr., in equal shares, and per stirpes, all of my real property, of whatsoever nature and wheresoever situated, which I might own or possess at the time of my death, but subject to the life estate herein granted to my beloved wife, Eunice Aster Turner.

VI

All the rest, residue and remainder of my estate, of whatsoever nature and wheresoever situated, I give, bequeath and devise unto my beloved wife, Eunice Aster Turner.

VII

I hereby nominate and appoint my son, Charles Turner, of Shelby County, Alabama, as my executor of this, my last will and testament, and I hereby direct that he, as said executor, be exempt from giving any bond, and from making any report or inventory of my estate to any Court.
