Quarter of said Section 16; thence in Northeasterly direction along the Northeast-
Southwest diagonal line of said Quarter-Quarter section 348.05 feet; thence turning an
angle of 45 degrees, 56 minutes, and 40 seconds to the right in easterly direction 70.44
feet; thence turning an angle of 47 degrees and 20 minutes to the right in Southeasterly
direction 336.79 feet to the point of intersection with North boundary of County Road
Right-of-way, said point being in arc of a curve turning to the right in Southwesterly
