herein, was issued Letters of Guardianship over the Estate of said ELIZABETH ARCHER, a person of unsound mind.

- 4. Your Petitioner avers that said ELIZABETH ARCHER, has recently suffered a general stroke and is now completely bedridden and requires constant care.
- 6. Your Petitioner further avers that she has expended various sums from her personal accounts to pay for medical care for the said ELIZABETH ARCHER. There is an additional balance of \$531.00 due and outstanding on other medical bills for the care of the said ELIZABETH ARCHER and in order that these debts may be satisfied it is necessary that certain assets of her estate be sold.
- 7. Among the assets of said Guardianship estate is the following real property:

Commencing at a point where the West line of the Southeast Quarter of the Southeast Quarter of Section 28, Township 19, Range 1 East, intersects the South line of Shelby County Road 55 for a point of beginning, thence run 225 feet Northeastwardly along said road to a point; thence run 780 feet South to a point; thence run 225 feet Southwestwardly parallel to said Shelby County Road 55 to the said West line of the Southeast Quarter of the Southeast Quarter of said Section 28, Township 19, Range 1 East; thence run North along said West line of said Section 28, Township 19, Range 1 East to the point of beginning, all of which said property is located in Shelby County; Alabama.
