- (a) I will, devise and bequeath unto my son, Zac T. Broyles, the bedroom furniture, sewing machine, chest of silver, silver service with the exception of the silver tray, gold rug, the watch and guns which formerly belonged to W. O. Broyles, all located at 81 Lakeshore Drive, Homewood, Alabama.
- (b) I further will, devise and bequeath unto 7ac T. Broyles the house and lot located at 1h78 Pearson Avenue, west En1, Birmingham, if I am seized and possessed of said house and lot at the time of my death, and in the event said property is not owned by me at the time of my death, I will, devise and bequeath unto the said Zac T. Broyles the sum of \$8,000.00 in cash in lieu of the above described property.
- (c) I will, devise and bequeath unto my daughter, Oze Broyles Currie my dwelling house and lot located at 81 Lakeshore Drive, Homewood, and all the fixtures and furniture therein, with the exception of the hereinabove articles bequeathed to Zac T. Broyles.
- (d) I further will, devise and bequeath unto Oze Broyles Carrie my rings and pin. and all the rest and residue of my estate after the payment of items A, & B & C.

ITEM FOUR

I hereby constitute and appoint my husband, W. O. In the event W. O. Broyles predeceases me, or dies simultaneously with me, then in that event I appoint Oze Broyles Currie and Zac T. Broyles

I direct that my said Executor shall have full power and authority to sell and convey any and all property, real, personal or mixed, which may be comprised in my estate, and to execute and deliver such instruments in writing as may be necessary to effect such sale and conveyance, without any order or orders of any court or courts.
