I, MAMIE BROYLES, a resident citizen of Birmingham, Jefferson County, Alabama, being of sound mind and disposing memory, do hereby make, publish and declare this my Last Will and Testament, hereby expressly revoking all other Last Wills and Testaments by me at any time heretofore made:

ITEM ONE

I direct that all my just debts and my funeral expenses be paid by my Executor, hereinafter named, as soon after my death as conveniently can be done.

ITEM TWO

All the rest and residue of my estate and property, real, personal or mixed, or of whatsoever kind, and wherever the same may be situated, of which I shall die seized and possessed, I will, devise and bequeath unto my husband, W. O. Broyles, to be his absolutely, and to be disposed of by him as he may see fit.

ITEM THREE

In the event my said husband, W. O. Broyles, shall pre-decease me or die simultaneously with me, then in that event it is my will that the following disposition be made of my estate:

(a) I will, devise and bequeath unto my son, Zac T. Broyles, the bedroom furniture, sewing machine, chest of silver, silver service with the exception of the silver tray, gold rug, the watch and guns which formerly belonged to W. O. Broyles, all located at 81 Lakeshore Drive, Homewood, Alabama.

(b) I further will, devise and bequeath unto Zac T. Broyles the house and lot located at 1478 Pearson Avenue, West End, Birmingham, if I am seized and possessed of said house and lot at the time of my death, and in the event said property is not owned by me at the time of my death, I will, devise and bequeath unto the said Zac T. Broyles the sum of \$8,000.00 in cash in lieu of the above described property.

(c) I will, devise and bequeath unto my daughter, Oze Broyles Currie my dwelling house and lot located at 81 Lakeshore Drive, Homewood, and all the fixtures and furniture therein, with the exception of the hereinabove articles bequeathed to Zac T. Broyles.

(d) I further will, devise and bequeath unto Oze Broyles Currie my rings and pin, and all the rest and residue of my estate after the payment of items A, & B & C.

ITEM FOUR

I hereby constitute and appoint my husband, W. O. Broyles, as Executor of this my Last Will and Testament, and it is my will that he not be required to make or give any bond for the faithful performance of his duties arising hereunder, nor to make any inventory of the property coming into his hands as such Executor, nor to make any report to any court whatsoever of his proceedings hereunder.

ITEM FIVE

In the event W. O. Broyles predeceases me, or dies simultaneously with me, then in that event I appoint Oze Broyles Currie and Zac T. Broyles

as Executors of this my Last Will and Testament, and it is my will that they not be required to make or give any bond for the faithful performance of their duties arising hereunder, nor to make any inventory of the property coming into their hands as such Executors, nor to make any report to any court whatsoever of their proceedings hereunder.

ITEM SIX

I direct that my said Executor shall have full power and authority to sell and convey any and all property, real, personal or mixed, which may be comprised in my estate, and to execute and deliver such instruments in writing as may be necessary to effect such sale and conveyance, without any order or orders of any court or courts.

IN WITNESS WHEREOF, I, the said Mamie Broyles, have hereunto set my signature and seal, on this the _____ day of April, 1949, declaring this instrument contained on these two sheets on which I have set my signature to be my Last Will and Testament.
