RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL NEN BY THESE PRESENTS, That Vulcan Materials Company, a corporation, in and for the consideration of One Dollar (\$1.00) in hand paid by Shelby County, the receipt of which is hereby acknowledged and for the further consideration of the benefit accruing to it and to the public from the construction or improvement of a public road through its lands in Shelby County, does hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right-of-way hereinafter described, over and across its said lands in Shelby County, Alabama, for a public road; which right-of-way shall be forty (40) feet in width on each side of the center line of said road, as it is now located and staked out by the State Highway Department or as much of its lands as is required to make an eighty (60) foot right-of-way across its lands, said right-of-way herein conveyed being more particularly described as follows, to wit:

From the northwest corner of Section 8, Township 22 South, Range 2 West run easterly along the north boundary line of said Section 8, Township 22 South, Range 2 West for 3907.52 feet; thence turn an angle of 90° -00' to the right and run southerly 50.0 feet to a point being Station 28 + 04.89 on the center line of the roadway herein described, said point being the point of curve to the left, said curve having the following characteristics: Intersection angle of 60° -40', the radius being 716.74 feet and the degree of curve being 80 -00', thence turn an angle of 90° -00' to the left and run easterly along the arc of the above-described curve for 40.0 feet to Station 28 + 44.89, the point of beginning of the right-of-way herein-described; thence continue along the arc of the above-described curve to Station 35 + 63.80 the point of tangent; thence continue northeasterly along the tangent to Station 43 + 18:80 the point of curve to the right, said curve having the following characteristics: Intersection angle of 640 -18', the radius being 572,96 feet, and the degree of curve being 100 -001, thence run along the arc of the curve to Station 49 + 61.81 the point of tangent, thence run easterly along the tangent to Station 60 + 06.74 to the intersection of the center line of the existing County Road and the ending of this right-ofway.

TO HAVE AND TO HOLD by Shelby County, or its assigns, and for. and in consideration of the benefit to Vulcan's property by reason of the construction or improvement of said road, Vulcan hereby releases the County aforesaid, and all of its employees and officers, and the State of Alabama and all its employees and officers, from all consequential damages, present or prospective, to its property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to its property is hereby admitted and acknowledged. All agreements covering the moving, relocating and/or changing of the buildings and/or structures located wholly or partially on the above-described right-of-way shall be in writing and approved by the State Highway Department before the same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during the construction period of the project for the purpose of moving grantor's buildings and/or structures from the above-described right-of-way.
