Andrew Jackson Earle Cross^{III}, who was my father, died intestate while a resident of Shelby County, Alabama, in 1935, and my mother, who was Lydia Acton Cross, died intestate while a resident of Shelby County in 1929. My said mother and father were never married except to each other, and they had a total of eight children, and ^{were survived by no children and} by no decendants of any deceased children, not specifically named below, said eight children being designated as follows: Needham L. Cross, Elizabeth Levert Cross Gilbert, Hubert Eric Cross, Hershel Woodson Cross, Mary Gertrude Cross, Nellie Geraldine Cross Wooten, Garland Wallace Cross, and myself, Gordon Samuel Cross.
