is hereby acknowledged and for the further consideration of the benefit accruing
to me and to the public from the construction or improvement of a public street
through our lands in ~~Exumbraxx~~ Shelby County, Alabama, do hereby give,

grant, bargain, sell and convey unto E. C. Wooten,
his heirs
~~successor~~ or assigns, a right of way hereinafter described, over and
across my lands in ~~Exumbraxx~~ Shelby County, Alabama, for a public street, or roadway
said right of way herein conveyed being more particularly described as follows,
to-wit:

An easement 10 feet on each side of center line as follows: Commence at
the northwest corner of $SE\frac{1}{4}$ of $NE\frac{1}{4}$, Section 23, Township 21 South, Range
3 West; thence south along the west boundary of said $SE\frac{1}{4}$ of $NE\frac{1}{4}$ a distance
of 242 feet to the point of beginning on center line of the easement
herein described; thence north 88 deg. 45 min. east (magnetic bearing)
along the center line of said easement, a distance of 244 feet to the point
of ending. Said easement being 20 feet in width and being situated in $SE\frac{1}{4}$
of $NE\frac{1}{4}$, Section 23, Township 21 South, Range 3 West.


