My name is Fred Yarbrough. I am <u>78</u> years of age and reside at Box 61, Calera, Shelby County, Alabama.

I have been familiar with the ownership and possession of the North Half of SE% of SE% of Section 4. Township 22 South, Range 2 West for the past <u>>5</u> years, having actually lived and resided within a mile of said property for the past <u>>5</u> years.

Said property, as shown by the Right of Way Map for Interstate Highway No. I-65 which is recorded in Right of Way Map Book 2 at page 9g, Office of Judge of Probate of Shelby County. Alabama, lies to the East of said Interstate Highway, a portion of the Western part of said property being taken by said Interstate Highway.

To my knowledge, there are no buildings or improvements situated on said property, nor have there been for the past 25 years. There is a cemetery or burial ground situated on said property, being approximately 1/2 acre.

Said property was originally owned by Green or Mary
Herndon and was owned by them when I first remember said property, and after their respective deaths, it is my understanding
that said property has now been conveyed by their heirs to John
S. Herndon (who is one of their children and heirs).

I know of my own personal knowledge that no one other than said John S. Herndon and his predecessors in title, as designated above, have possessed said property, or any part thereof, for the past 25 years, said John S. Herndon and his said predecessors in title having been in the actual, open, continuous,

notorious, undisturbed, peaceable, exclusive, hostile, adverse possession of all of said property for the past <u>Z5</u> years.

I personally know Mack Goodlet and his wife, Doris Goodlet, said Mack Goodlet being the brother of my wife, Earnestine Yarbrough. Said Mack Goodlet bought a lot from said Green Herndon and Mary Herndon about 1946 which is situated to the West of said Interstate Highway and fronting on the East side of U. S. Highway 31, as shown by said map of said Interstate Highway above referred to. To my knowledge, said Mack Goodlet and Doris Goodlet own no property to the East of said Interstate Highway.

All of the property of the New Mt. Moriah Bantist Church (also known as the New Mountain Moriah Baptish Church) lies to the west of said Interstate Highway of said U. S. Highway No. 31.

I do not know Susan Hart, S. C. Cost, nor James Taylor, nor have I ever heard of their owning, possessing, or claiming any part of the above described property of John S. Herndon.

The lot shown by the map of said Interstate Highway above referred to lying to the west of said Interstate Highway, fronting on the east side of U. S. Highway, and shown on said right of way map to be possessed by Rosa Williams, is the property formerly owned by Wendell Herndon. Said Wendell Herndon, now deceased, was the brother of said John S. Herndon, the son of said Green and Mary Herndon, and after the death of said Wendell Herndon, his widow, Rosa Herndon, married Lepera Williams.

The bt shown on the map of said Interstate Highway above referred to lying to the west of said Interstate Highway, fronting on the east side of U. S. Highway No. 31, and adjoining said Mack Goodlet property on the south, and shown by said map to be possessed by Tom Hill, is now owned, or was formerly owned, by Lula Webb. The house which was situated on said lot burned about fifteen years ago. Tom Hill is the brother of Lula Webb, said Lula Webb being deceased.

Highway 31 and adjoining said Rosa Williams lot on the north is now owned by Lizzie Smith, the widow of said George Smith, and by the heirs of said George Smith.
