Turner and Mary Ann Turner, the receipt whereof is hereby acknowledged, does hereby release, remise, and quit claim unto the said Harold L. Turner and Mary Ann Turner all the right, title and interest acquired under said mortgages in and to that part of the premises conveyed therein and described as follows, to-wit:

Commence at the Northwest Corner of the Southwest One-fourth of the Northwest (ne-fourth of Section 10, Township 19 South, Range 2 East, Shelby County, Alabama; thence proceed South along the West boundary of said quarter-quarter section for e distance of 119.67 feet to a point. From this point turn an angle of 550 13' to the left and proceed South 560 13' East for a distance of 358.97 feet to a point on the Southwest right-of-way line of a county road and the point of beginning of land herein described. From this beginning point turn an angle of 73° 04' to the right and proceed South 16° 51' West for a distance of 277.65 feet to a point; thence turn an angle of 720 27' to the left and proceed South 550 36' East for a distance of 160 feet to a point; thence turn an angle of 1370 30' to the left and proceed North 60 54' East for a distance of 300 feet to a point on the Southwest right-of-way line of the aforementioned road; thence proceed North 560 131 West along the Southwest right-of-way line of said road for a distance of 125 feet to the point of beginning.

The above described land is located in the Southwest One-fourth of the Northwest One-fourth of Section 10, Township 19 South, Range 2 Fast, Shelby County, Alabama, and contains 1.01 acres.

TO HAVE AND TO HOLD the same to the said Harold L. Turner and Mary Ann Turner, and to their heirs and assigns forever.

This release shall not in any way impair or affect the right of said mortgagee to hold the remainder of the premises conveyed in said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid.
