KNOW ALL MEN BY THESE PRESENTS, That I, ANEST SARINOPOULOS, of Fairfield, Jefferson County, Alabama., being of sound mind and disposing memory, do make and publish this My Last Will and Testament, hereby revoking all former Wills by me at any time heretofore made.

As to my worldly estate, and all the real, personal or mixed property of which I shall die seized and possessed, or to which I shall be entitled to at the time of my decease, I devise, bequeath and dispose thereof in the manner following, to-wit:

FIRST; My Will is that all my just debts and funeral expenses shall, by my Executrix, hereinafter named, be paid out of my estate as soon after my decease as convenient.

SECOND; I give, devise and bequeath to my beloved wife, CHRISTINE A. SARINOPOULOS, all my personal property, all my real property, all my mixed property, of which I shall die seized and possessed, or to which I may be entitled to at the time of my death, to be hers absolutely.

And I do give, devise and bequeath to my said beloved wife, CHRISTINE A. SARINOPOULOS, all my real, personal or mixed property of which I shall die seized and possessed, or to which I shall be entitled to at my decease, to be hers absolutely.

THIRD; I do nominate and appoint my said beloved wife, CHRISTINE A. SARINOPOULOS, to be the Executrix of this My Last Will and Testament.

FOURTH; My Executrix shall not be required to give any Bond, as such Executrix, to any Court, and I hereby request that my said Executrix shall be hereby relieved from executing Bond to any Court for any purpose, as Executrix of this My Last Will and Testament. My Executrix shall not be required to make any Inventory of my estate to any Court, or make any final settlement of my estate, as such Executrix, to any Court.

IN WITNESS WHEREOF, I, the said ANEST SARINOPOULOS, have to this, My Last Will and Testament, subscribed my name and affixed my seal, this the 12th day of January, 1942.
