the following described real estate situated in Shelby..... County, Alabama, to-wit:

Begin at the north east corner of the southwest quarter of the north east quarter of Section 26, Township 19, Range 1 West, and run along the east boundary of said forty, south 3 degrees east 179 feet to a point where the east boundary of said forty intersects the south line or margin of the right of way of what is known as the Florida Short Route Highway; thence along the south line or margin of said Highway south 73 degrees 15 minutes west 326 feet to the point of beginning of the lot herein conveyed, and from said point of beginning, continue along the south margin or line of said Highway south 73 degrees 15 minutes west 222 feet; thence south 2 degrees 15 minutes east 315 feet; thence north 87 degrees 30 minutes east 210 feet; thence north 2 degrees 15 minutes west 386 feet to the point of beginning of the lot herein conveyed containing 1.70 acres more or less, and being a part of the south west quarter of the north east quarter of Section 26, Township 19, Range 1 West, excluding a portion of the above description in the north west corner as follows; beginning at the north west corner of above described and run east 50 feet along margin of the right of way of said highway; then turn 90 degrees south 150 feet; then west 88 degrees 33 minutes 97.57 feet to the west boundary line; then north 73 degrees 37 minutes 155 feet along west boundary line to the point of beginning.
