Lot No. 7 of the Willow Island Subdivision according to the plat thereof recorded in Map Book 4 at page 73 in the Probate Office of Shelby County, Alabama, said Subdivision being a part of the Northwest Quarter of Southeast Quarter (NW2 of SEX) of Section 13, Township 22 South, Range 1 East, together with the right of ingress or egress over and across the lands lying between the above-described lot and the waters of the Coosa River including the rights to use a causeway, boat launching facilities and picnic area situated in said subdivision and subject to the building and other protective covenants recorded in Deed Book 220 at page 891 in the office of the Judge of Probate of Shelby County, Alabama.

This coveyance is subject to the land interests and land rights heretofore acquired in the above described lands by the grantee, and to any existing easements and rights of way.
