AGREEMENT

The undersigned, THOMAS G. STAMPS and wife, BRIDGIE STAMPS, did by deed filed for record in Deed Book 251, Page 154, in the Probate Office of Shelby County, Alabama, acquire and purchase a part of the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 20, Township 21, Range 2 West, and

At the time of such purchase it was recognized by the undersigned that a fence had been erected, and was in existence outside of the property lines purchased by the undersigned. The Grantor in the above referred to deed has contracted to sell to William C. Wood of Birmingham, Alabama other real estate which abuts on the property conveyed to the undersigned as described in said deed. In order to clear up any doubt as to the property claimed by the undersigned which doubt may have arisen from the location of such fence, the undersigned has executed this agreement.

It is expressly understood and agreed that the undersigned claim no right, title or interest in and to any part of said NW $\frac{1}{4}$ of SE $\frac{1}{4}$, except that portion particularly described by metes and bounds in the above referred to deed.

We also understand and recognize the fact that we are presently obtaining our water from a well located between our property line and the above referred to fence. William C. Wood has agreed that when he completes the purchase of the property which includes such well, that he will continue to permit us to use the water from this well for as long as it does not in his opinion deprive him of water or interfere with his proposed use of his property. We also by this agreement agree and covenant with Mr. Wood that at any time he notifies us in writing to the effect that we are to discontinue the use of

the water from the wlls located on his property, we will comply with such request and discontinue the use of such wells, provided Mr. Wood allows us 30 days from the time of his notice to us so that we may have a reasonable time to provide another source of water for ourselves and our family.
