protection facilities consisting of by-passes, cross-overs, poles, power lines, cables, meters, anodes, ground beds,
fittings and other apparatus and equipment necessary for the control of electrolytic action on Grantee's pipe
line(s) on, over, and through the following described lands situated in Shelby (County,
Parish), State of Alabama, to wit:

and assigns so long as said cathodic protection facility is maintained on, over, and through said lands.




