My name is H. M. Merrell. I am 58 years/and reside at Route 1. Shelby, Shelby County, Alabama.

I have been familiar with the ownership and possession of the NW% of NW% of Section 6, Township 24 North, Range 16 East, minerals and mining rights excepted, for the past 40 years or more years, having been the owner of said property since January, 1945, and having actually lived and resided on said property continuously since 1945 and until the present time.

I bought said property from Mr. E. S. Pearson in January, 1945, receiving a warranty deed, immediately taking possession of said property under said warranty deed.
