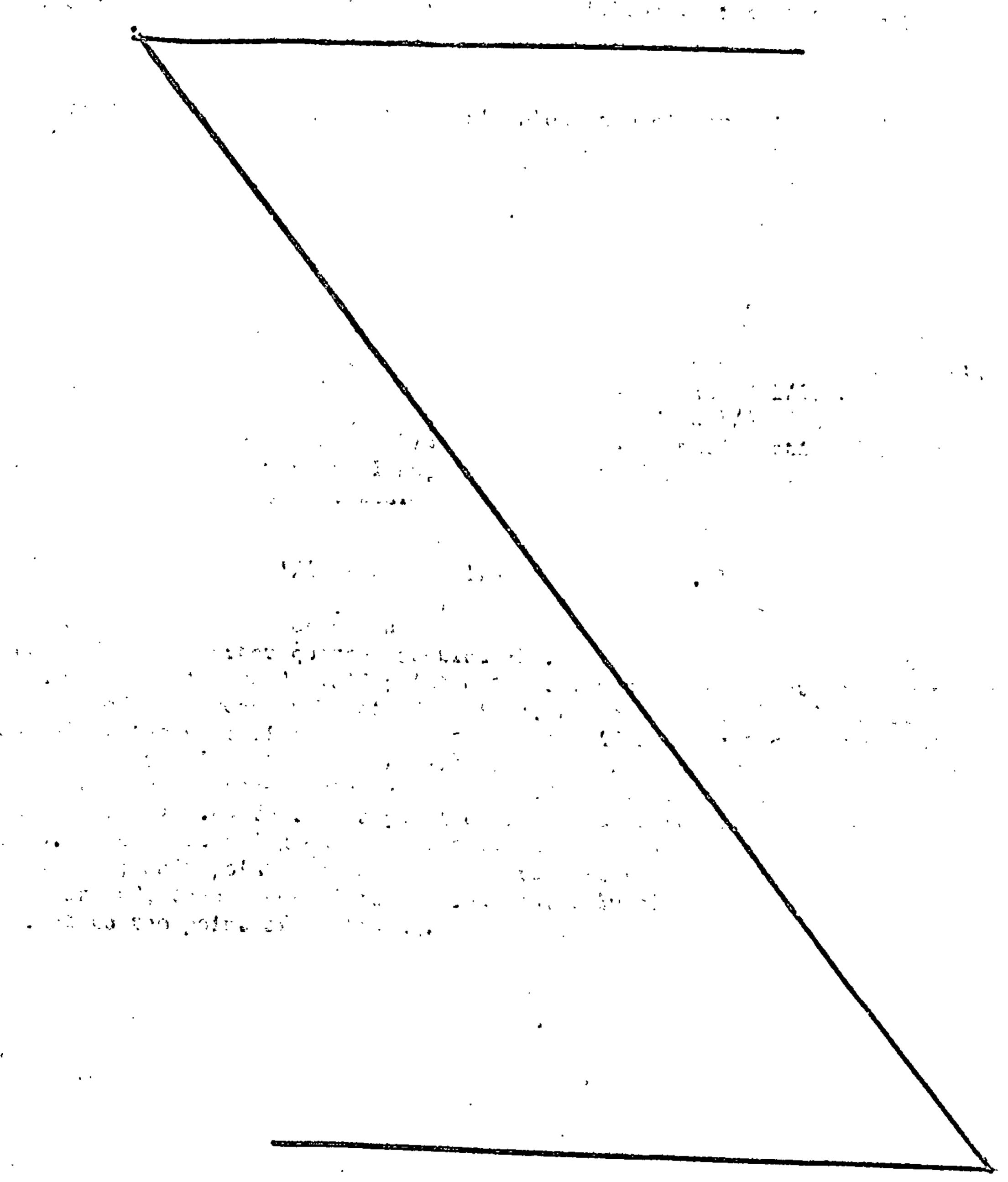

WARRANTY DEED.

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of fifteen thousand and no/100 dollars (\$15,000.00) and other valuable considerations, to the undersigned Grantors, Levert G. Gravlee and Frances M. Gravlee, husband and wife, in hand paid by James G. Nash, the receipt whereof is hereby acknowledged, We, the said Grantors, Levert G. Gravlee and Frances M. Gravlee, husband and wife, have sold, and we do hereby grant, bargain, sell and convey unto the said James G. Nash, the following described real property, situated in Shelby County, Alabama, vis:

PARCEL 1:

A tract of land cituated in the Esst 1/2 of the NH 1/4 and in the West 1/2 of the NE 1/4 of Section 29, Township 19 South, Range 2 West, in Shelby County, Alabama, particularly described as follows: Commanca at the Southeast Corner of the SW 1/4 of the NE 1/4 of eastd Section 29 and run thence westerly along the South line thereof for a distance of 35.0 feet to a point in a 60 foot road, said point being on the nub-tangent of a center line curve having a central angle of 59° 26', said point being the point of beginning of the property herein described; thence turn 88° 33' 45" right and run northarly along said sub-tangent for a distance of 21.83 feet to the P.I. (point of intersection) of said curve; thence turn 59° 26° laft and run northwesterly along the center line of said road 225.18 feet to the P.C. (point of curve) of a curve to the right having a central angle of 40° 42' 30" and a radius of 335.00 fact: thanco run northweaterly alone the are of autd curve and along the center line of said road 284.79 feet to the P.T. (point of tangent) of paid curve; thence continue northwesterly along the center line of said road, on a course that is tengent to last said curve. for a distance of 469.83 feet to the P.I. of a curve having a central angle of 29° 32'; thence turn 29° 32' left and run northwesterly along the center line of said road 460.26 feet to the P.I. of a curve having a control angle of 45° 46' 30"; thence turn 45° 46' 30" right and run northerly along the center line of said road 511.63 feet to the P.I. of a curve having a central angle of 27° 40'; thence turn 27° 40' left and run corthwesterly along the center line of said road 179.65 fact to the P.I. of a curve having a central angle of 50° 00' 30"; thence turn 50° 00' 30" right and run northeasterly along the center line of said road 279.72 feet to the P.C. of a curve to the left having a central angle of 147° 33' and a radius of 35.00 fest; thence run northwesterly and southwesterly along the are of last said curve 90.13 feet to the P.T. of said curve; thence continue southwesterly along the center line of said road, on a course that is tangent to last said curve, 406.15 feet to the P.I. of a curve having a central angle of 4° 41'; thence turn 4° 41' right and run couthweaterly along the center line of said road 477.53 feet to the P.I. of a curve to the right having a central angle of 23° 05'; thence turn 23° 05' right and run southwesterly along the center line of said road 94.70 feat to the P.I. of a curve having a central angle of 20° 37' 30"; thence turn 20° 37' 30" left and run pouthwesterly along the center line of waid road 527.82 feat to the P.I. of a curve having a central angle of 21° 03'; thence turn 21° 03' left and run southwesterly along the center line of said road 202.37 feat to the P.I. of a curve having a central angle of 12° 57'; theace turn 12° 57' laft and run southwesterly 240.53 feet to the P.I. of a curve having a central angle of 26° 26'; thenca turn 26° 26' right and run southwesterly along the center line of said road 334.54 feet, more or less, to an intersection of said conter line with the West line of the SE 1/4 of the NW 1/4 of said Section 29; thence turn 59° 45° 30" left and run southerly along paid West line of the SE 1/4 of the NW 1/4 for a distance of 961.44 feet, nore or less, to the Southwest corner of said SE 1/4 of the NW 1/4; thence turn laft and run easterly along the South line of said 8E 1/4 of the NW 1/4 and along the South line of the SW 1/4 of the NE 1/4 of said Section 29, for a distance of 2612.86-ft, more or less, to the point of beginning. Minorals and mining rights excepted.

Parcol 2:

A tract of land in the NW 1/4 of the NE 1/4 of Section 29, Township 19 South, Range 2 West in Shelby County, Alabama, described as follows: Commonce at the SE corner of said quarter-quarter section and run thence westerly along the south line of said quarter-quarter section 758.62 feet to a point on the center line of a 60 foot wide road, said point being the southwest corner and the point of beginning of the property herein described; thence turn 180° 00' and run easterly along the same line 758.62 feet to the said southeast corner of said quarter-quarter section; thence turn 91° 26' left and run northerly along the East line of said quarter-quarter section 285.00 feet; thence turn 90° 00' left and run westerly 732.80 feet to a point on the said center line of a 60 feet wide road, said point being on a curve curving to the left and having a radius of 250.84 feet; said point also being the northwest corner of the property herein described; thence turn left and run southerly along the said center line 267.21 feet to the point of beginning.

Parcel 3:

Commence at the N.E. corner of the NW 1/4 of the NE 1/4 of Section 29, Township
19 South, Range 2 West, in Shelby County, Alabama, and run thence westerly along
the north line of said quarter-quarter section for a distance of 977.07 feet to
the point of beginning of the property herein described; thence continue westerly
along the last described line for a distance of 332.93 feet; thence turn 115° 42°
left and run southeasterly for a distance of 748.60 feet to the center line of a
road; thence turn 95° 28° 40" left and run northeasterly along the center line of
said road for a distance of 301.37 feet; thence turn 84° 31° 20" left and run
northwesterly for a distance of 576.72 feet to the point of beginning.

Parcel 4:

A parcel of land situated in the SW 1/4 of the NE 1/4 of Section 29, Township 19 South, Range 2 West, in Shelby County, Alabama, particularly described as follows: Commence at the northeast corner of said quarter-quarter section and run thence southerly along the east line thereof for a distance of 219.16 feet to the point of beginning of the property herein described; thence turn 82° 50° right and run southwesterly for a distance of 642.74 feet to a point on the center line of a 60 foot wide road; thence turn 123° 08° 30" left and run southeasterly along said center line for a distance of 250.18 feet to the P.I. (point of intersection) of a curve having a central angle of 29° 32°; thence turn 29° 32° right and run southeasterly along the sub-tangent of said curve for a distance of 68.51 feet to a point on said sub-tangent; thence turn 90° 38° left and run northeasterly for a distance of 472.41 feet to a point on said east quarter-quarter section line; thence turn 78° 35° left and run northerly along said east quarter-quarter section line; thence turn 78° 35° left and run northerly along said east quarter-quarter section line for a distance of 245.0 feet to the point of beginning.

Parcel 5:

A parcol of land situated in the NW 1/4 of the NE 1/4 of Section 29, Township 19 South, Range 2 West, in Shelby County, Alabama, particularly described as follows: Commence at the southeast corner of said quarter-quarter section and run thence northerly along the east line thereof for a distance of 835.00 feet to the point of beginning of the property herein described; thence continue northerly along said quarter-quarter section line for a distance of 423.35 feet to a point on the center line of a 60 foot wide road; thence turn 122° 32' left and run southwesterly along said center line for a distance of 417.08 feet to the P.I. (point of intersection) of a curve to the left having a central angle of 48° 17' 30"; thence turn 48° 17' 30" left and run southwesterly along said center line for a distance of 249.91 feet to a point on the sub-tangent of a curve to the right having a central angle of 33° 50'; thence turn 106° 10' left and run northeasterly for a distance of 394.39 feet to the point of beginning.

Parcel 6:

A parcel of land situated in the NW 1/4 of the NE 1/4 and in the NE 1/4 of the NW 1/4 of Section 29, Township 19 South, Range 2 West, in Shelby County, Alabama, particularly described as follows: Commence at the northeast corner of the NW 1/4 of the NE 1/4 of said Section 29 and run thence westerly along the north line thereof for a distance of 1310.0 feet to the point of beginning of the property herein described; thence turn 40° 11' 30" left and run southwesterly for a distance of 929.58 feet to a point; thence turn 10° 04' 20" right and run southwesterly for a distance of 300.89 feet to a point; thence turn 85° 34' 50" left and run southcasterly for a distance of 467.36 feet, more or less, to a point on the subtangent of a curve of the center line of a 60 foot wide road; thence turn 109° 23° 10" left and run northeasterly for a distance of 39.41 feet to the P.I. (point of intersection) of said curve which has a central angle of 21° 03'; thence turn 21° 93' right and run northeasterly along the center line of said 60 foot wide road for a distance of 527.82 feet to the P.I. of a curve having a central angle of 20° 37' 30"; thence turn 20° 37' 30" right and run easterly for a distance of 94.70 feet to the P.I. of a curve having a central angle of 23° 05'; thence turn 23° 05' left and run northeasterly for a distance of 477.53 feet to the P.I. of a curve having a central angle of 4° 41'; thence turn 4° 41' left and run northcasterly along gaid center line for a distance of 70.42 fact to a point; thence turn 84° 31° 20" loft and run northwesterly for a distance of 748.60 feet, more or less, to the point of beginning.

The minerals within and underlying the premises, together with all mining rights, and other rights, privileges and immunities relating thereto, as were reserved in a deed recorded in Deed Book 42, page 246 in the Probate Office of Shelby County, Alabama, are excepted from the hereinbefore described real property, and are reserved and are not conveyed hereby.

This conveyance is made subject to the right-of-way granted to Alabama Power Company, as shown by instrument recorded in Deed Book 124, page 493, and in Deed Book 214, at page 631 in the Probate Office of Shelby County, Alabama.

There is also excepted out of the real property herein conveyed that part of same which islocated in the rights of way of Indian Crest Drive and Lookout Trail.

As a part of the consideration herefor, the Grantee herein, James G. Nash, shall execute and deliver to the Grantors, Levert G. Gravlee and Frances M. Gravlee, a purchase money first mortgage, conveying said property, to secure the payment of \$140,000.00, due as balance of consideration for this conveyance.

TO HAVE AND TO HOLD, the said real property, unto the said James G. Nash, his heirs and assigns, forever.

And, we do, for ourselves and for our heirs, executors and administrators, covenant with the said James G. Nash, his heirs and assigns, that we are lawfully seized in fed simple of said premises; that they are free from all encumberances; that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said James G. Nash, his heirs and assigns, forever, against the lawful claims of all persons.
