76 ft. Then East 30 ft. to starting point.

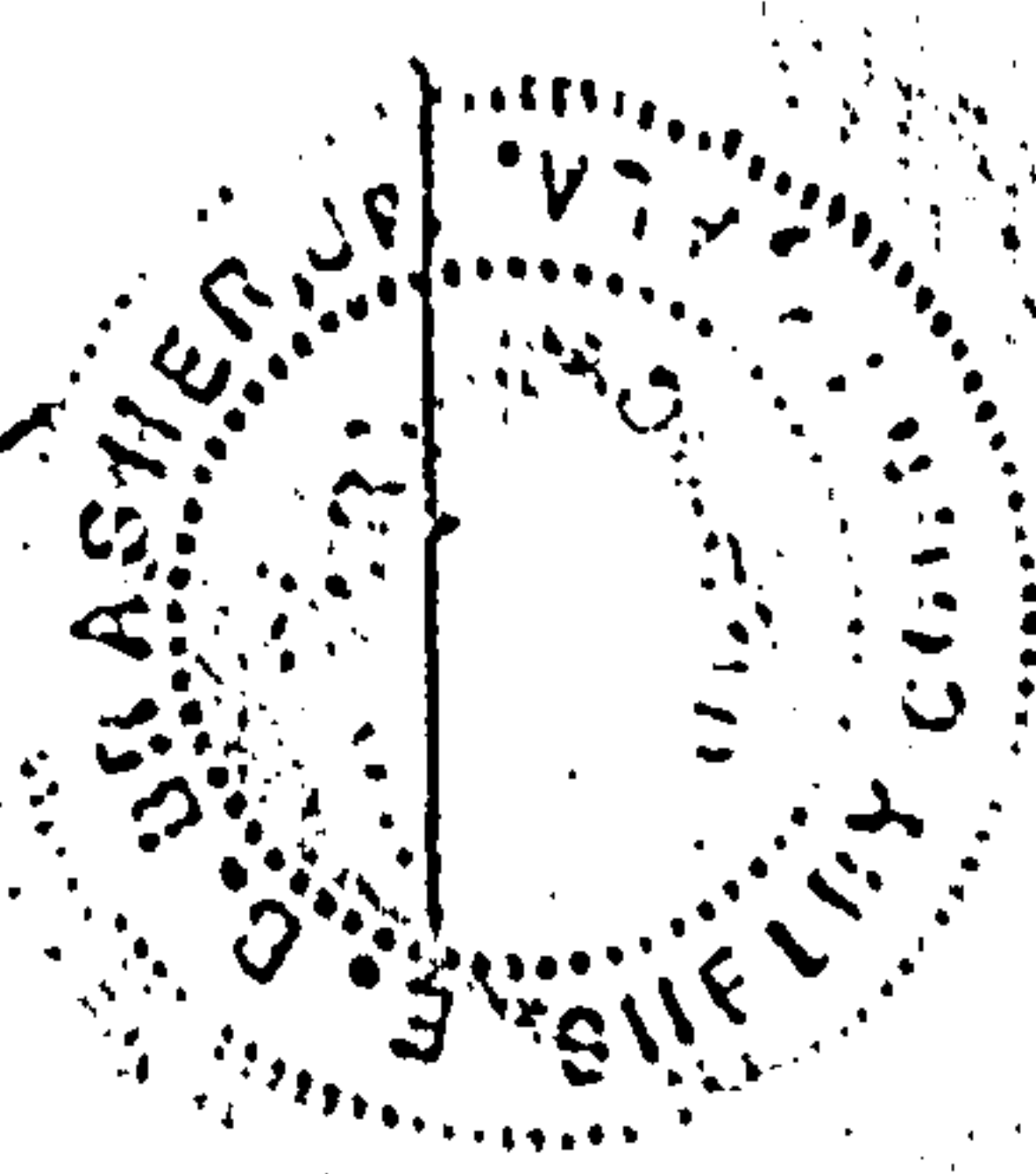
To have and to hold; To the said H.E. White & wife Dessie White

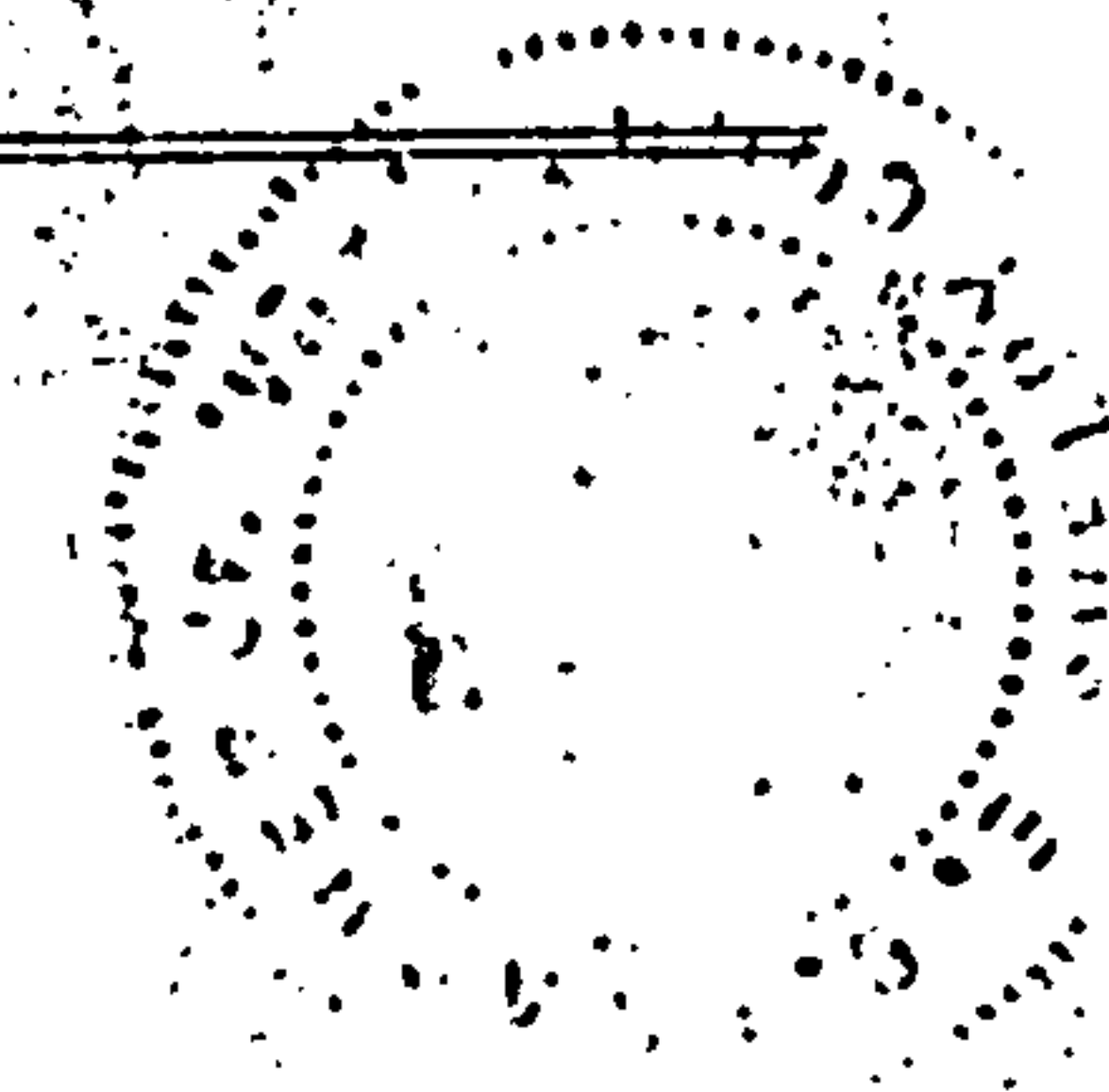
