ITEM I

As soon as practicable after my death, I direct that all of my debts, including my funeral expenses and expenses of my last illness, be paid by my Executrix, hereinafter named.

ITEM II

All of the rest, residue and remainder of my property, of whatsoever kind and character and wheresoever situated including whatever interest I may have in pending litigation, I give, bequeath, devise and appoint to my beloved wife, Willie Bailey Williams, to be hers absolutely.

ITEM III

give bond to guarantee or insure the faithful performance of her duties as such Executrix nor be required to render any accounting and shall have and exercise, as Executrix, without order of court, the following powers with respect to my estate, namely:

To hold and manage my estate and any other property which may be acquired with full power to collect the income therefrom and, from time to time, sell, convey, exchange, lease for a period beyond the termination of the administration of my estate, or for a lesser period, improve, encumber, borrow on the security of, or otherwise dispose of all or any portion of my estate in such manner and upon such terms and conditions as my said Executrix may approve, and with full power to invest or reinvest my estate and the proceeds of the sale or disposal of any portion thereof in such loans, stocks, bonds or other securities, mortgages, common trust funds or other property, real or personal, as may be deemed to be suitable, and to change investments and make new investments from time to time as she may deem to be necessary or desirable; to pay all interest, taxes, administration expenses, and miscellaneous maintenance charges on property consisting of the corpus of my estate from the income of my estate, if sufficient, if not sufficient, then the same may be paid from the corpus of my estate. Said Executrix shall be and is hereby relieved of all expenditures on property, both real and personal, made by the custodian of any property received hereunder. Said Executrix is further relieved of any failure to make repairs, liability for depreciation and decline in market value of any property.
